A. CALL TO ORDER AND FLAG SALUTE

President Winn called the meeting to order at 9:00 a.m. and led the flag salute.

There was no public comment.

C-1) SHERIFF LT. MARTIN BASTI, COMMANDER OF SOUTH COUNTY SHERIFF STATION Presentation of sheriff activities in the Nipomo area

Sheriff Basti reported to the Board that there were a couple of commercial robberies this past month. There are plans to apply identification tags to farm equipment.

There will be a memorial service in May for officers who lost their life in the line of duty.

Lt. Basti will report to NCSD at the second meeting in May instead of the first.

There will be a Law Enforcement Special Olympics Torch Run. It will be in Nipomo Tues. June 8. Law Enforcement Officer's raise money for Special Olympics.

President Winn asked Lt. Basti if a list of crimes is available. Lt. Basti will get the information to the District soon.

 - D-1) WORKERS COMP CONTRACT WITH SPECIAL DISTRICT WORKER'S COMPENSATION ASSOCIATION (SDWCA)

Review and consider resolution to contract with SDWCA Worker's Comp Program

The Board discussed possible participation in the SDRMA Workers' Compensation Program.

Director Wirsing made a motion and Director Trotter seconded to participate in the SDRMA workers' compensation program.

The following members of the public spoke:

Bonnie Eisner, workplace insurance representative - stated that she manages a workers' comp group with floor covering and asked the Board if they had looked into Capture Programs for the workers' comp. The rates are significantly lower.

Director Wirsing withdrew the motion and Director Trotter withdrew the second.

Upon motion by Director Vierheilig and seconded by Director Wirsing, the Board agreed to table this item until the May 12th meeting to give time to check about other insurance programs. Vote 5-0.

D-2) DISTRICT INJURY AND ILLNESS PREVENTION PROGRAM (IIPP) Introduction and review of revised District IIPP

The Injury and Illness Prevention Program was introduced and discussed. The Board will put comments in writing and submit before the May 12, 2004, meeting.

There was no public comment.

Upon motion by Director Vierheilig and seconded by Director Wirsing, the Board agreed to circulate the draft of the IIPP to employees for questions and comments. Vote 5-0.

President Winn commended staff for the work on this document and asked that it be noted in the Minutes.
