CALL TO ORDER AND FLAG SALUTE

President Manriquez called the Regular Meeting to order and led the flag salute.

Manager Ray stated that the system is failing - there's approximately 2 to 3 feet of sewage which is plugging the lines. He felt that for about \$15,000 the septic system could be connected to the sewer. He further stated that the County would contribute \$7800, and mentioned that the District has a \$10,000 CD for the PSHH project.

However, there would be a \$3500 sewer connection fee. Ryder stated that if the Regional Board acts on a failing system it would have to be done immediately irregardless of the cost. At the present time the District would not have to pay 'any funds out of pocket'.

General Counsel Shaw informed the Board that the present agreement with the county has to be amended. He also stated that we don't want to form an assessment district with the County.

Director Fairbanks asked how payments would be made. Attornye Shaw stated that if an A.D. was formed for 20 to 30 years it would be added to property taxes - which could possibly be 30 to 40% over cost.

Director Small inquired about the County dumping water from a new tract into their basin and he wanted to know if the terrain has been altered with this process. He also asked what is the definition of 'failed'?

Legal Counsel stated when there is raw sewage in an open area health related problems could surface.

Ryder also said that the final audit on the sewer system grant has to be completed before CSA I can annex to the District.

Director Manriquez wondered why the County stopped taking care of the area when they knew it might fail. (Someone said they did it on purpose).

Legal Counsel informed the Board that there are 4 groups involved - Home Owners', SLO County, Regional Board and the District.

Manager Ray suggested that perhaps opening up negotiations with Supervisor Ruth Brackett might help.

One of the homeowners in attendance asked if they should get a lawyer. He was told that at the present time it wouldn't help.

Director Small moved, seconded by Director Fairbanks to direct staff and legal counsel to prepare a resolution for the next meeting. Unanimously approved by the Board.

MANAGERS REPORT

Ryder mentioned that until Santa Barbara County has their election on June 4, 1991 for state water we should do nothing.

Also mentioned was the fact that P.S.H.H. would be closing their escrow the early part of June.

He then informed the Board that he would be on vacation until June 26, 1991. In the meantime they would get a copy of the budget so that when he came back they could meet to review it.

Tract 1898 is going thru Galaxy Park on a separate force main in the road all the way to our gravity flow where the District will pick-up at the manholes.

President Manriquez stated that the District should not accept the responsibility for the system until it gets to our manholes.

Ryder stated that this is an expense we are paying for but the County must reimburse us.

Ryder plans to have a contractor in and out of the project in approximately 1 week.
