Costs for the State Water Project were questioned, as well as the allocation figures for the District.

Mr. Luis asked why the cost of state water had gone from \$530 to \$662 and acre foot. It was stated that

original figures had not taken the inflation factor into consideration.

General Counsel Shaw answered a question regarding water being shipped out of the area. This has to be done in some areas to alleviate the ground water condition.

Mr. Guyliash (?) wondered why more hadn't been said about state water at this meeting.

He also asked why water will be treated up north instead of down here. Manager Ray stated that treated water is easier to transport. You don't have the algae problem or the maintenance costs for the transportion.

If this wasn't taken care of you you might have to have 15 treatment plants in San Luis Obispo.

Mr. Fox asked about the arguments and rebuttals for the upcoming election.

General Counsel Shaw stated that the Board has a duty to be impartial with their statements.

Again the question was asked whether a person owning property in the District could vote. (Only registered voters in the District can vote).

Mr. Luis stated "you're having us run a special election, having to do it twice. You also deserve to pay the expenses or resign".

Director Fairbanks suggested that Mr. Luis wait for the election.

Mr. Guyiash asked about the algae in the existing canal. Mr. Ray answered that in the American River they have put tolapia (?) fish in to eat the algae.

A question was asked what do we do if we have excess water. Manager Ray stated that after checking with the San Luis Obispo Flood Control District we would in all probability sell the water to Los Angeles.
