The Board discussed the item and then tabled the item until after the July 18 meeting at the Region Water Quality Control Board. No action was taken.

- 5. LAFCO APPROVAL OF TRACT 1948 TO CSA 1-F Review LAFCO's action on approving annexation to CSA 1-F. Mr. Jones explained that this was an "information only" item. This matter will be continued at future meetings.
- 6. SLO COUNTY PROPOSED ZERO TAX TRANSFER ON ANNEXATION NO. 15 (NEWDOLL)

 Receive direction from the District Board on proceeding in this matter.

Bob Newdoll, owner of the 5 acre parcel at Hazel Lane & Tefft St., spoke at the meeting.
Directors mentioned that they couldn't separate annexation from the need for supplemental water.
This item will be on the SLO County Board of Supervisor's meeting on July 11, 1995.
No action was taken on this item.

7. REVISE THE DISTRICT WATER BILLING CODES (PUBLIC HEARING)

Introduction of proposed billing changes to bi-monthly, property owner liability, discontinuance procedures, increase turn off charge, eliminating deposits, etc.

President Small opened meeting to a Public Hearing.
Mr. Seitz explained some of the changes that were made
to the proposed ordinance. Director Small noted some
changes needed. Upon motion of Director Fairbanks and
seconded by Director Simon, the Board unanimously
approved Mr. Seitz to read the ordinance in title only.
Mr. Seitz read the ordinance and summarized it.

Upon motion of Director Simon and seconded by Mendoza, the Board unanimously approved to adopt the first reading of Ordinance 95-81 and set a Public Hearing for July 19 for the second reading.

> > Mr. Jones explained that different insurance companies were contacted to get quotes on premiums for dental insurance. Our current carrier, Delta Dental, has increased its premiums 15% effective 8/1/95. Guardian provided lower premiums with comparable benefits. Upon motion of Director Blair and seconded by Director Fairbanks, the Board unanimously approved to direct staff to change the employee insurance from Delta Dental to Guardian.

TRACT 1749, SUBDIVISION AT SHERIDAN RD. & HWY 101 (MOORE) Request to revise Intent-to-Serve letter from 15 lots to 36 lots. Director Simon gave a Sub-committee report concerning Mr. Moore's request to revise the District's Intent-to-Serve from 15 lots to 36 lots at Tract 1749. Director Mendoza suggested that the Intent-to-Serve be approved with the conditions spelled out in the Board letter.

Mr. Robert Moore spoke from the audience and said he would agree to abide by the conditions of the letter.

Upon motion of Director Simon and seconded by Director Mendoza, the Board unanimously approved to expand the Intent-to-Serve from 15 lots to 36 lots with conditions in the July 5 Board letter.
