SOUTHLAND SEWER REIMBURSEMENT - PUBLIC HEARING

Review and adoption of reimbursement cost spread to properties benefiting from sewer line improvements (Res. 99-711)

A cost spread was developed from information provided by Mr. Robert Newdoll for the Honey Grove Lane project. Those property owners who can benefit from the sewer line constructed from Frontage Rd. to Honey Grove Lane will pay a reimbursement to Mr. Newdoll (the developer) when or if their property is connected to the sewer line within the next ten years. No written protests were received.

4. REQUEST TO MAINTAIN OPEN SPACE - TRACT 2331 (WITTSTROM)

Developer of Tract 2331 requests the District own and maintain the open space of Tract 2331 Mr. Karl Wittstrom, developer of Tract 2331, has requested that the District hold title to the open space, maintain equestrian and bicycle trails on the open space and set a "Zone of Benefit" to acquire the funds to maintain the open space and recreational program.
