#### REQUEST FOR SERVICE

- a) TRACT 2212 Request for water & sewer service for an eight (8) lot development at Primrose & Manriquez
  - Erik Benham of TrinCon, Inc. requested water and sewer service for an eight lot development near the intersection of Primrose Lane and Manriquez Court. There were no public comments. Upon motion of Director Simon and seconded by Director Mendoza, the Board approved an Intent-to Serve letter with the conditions outlined in the Board letter for Tract 2212. Vote 4-1 with Director Kaye dissenting.
- b) TRACT 1713 Request for water service for a twelve (12) lot development at Camino Caballo & Red Gum
  - J. M. McGillis requested water service for a twelve lot development near the intersection of Camino Caballo & Red Gum Lane for owner Ed Grijalva and others. There were no public comments. Upon motion of Director Mendoza and seconded by Director Simon, the Board approved an Intent-to Serve letter with the conditions outlined in the Board letter for Tract 1713. Vote 4-1 with Director Kaye dissenting.
- TRACT 1854 Request for water and sewer service for a six (6) lot development at Juniper Street and Daffodil Avenue
  - Sean Greenwald. requested water and sewer service for a six lot development near the intersection of Juniper Street and Daffodil Avenue for himself and other owners.

During this agenda item, the following member of the public spoke:

<u>Sean Greenwald, 808 Juniper Street, Nipomo</u> - mentioned that lots 1 & 2 shown on submitted map changed access to Daffodil rather than Juniper.
