COUNTY SERVICE AREA NO. 1 - SEWER SERVICE AGREEMENT

ITEM

Request from SLO County to amend the NCSD/CSA 1 sewer services agreement to add units for Tract 2196 within Galaxy Park

BACKGROUND

Your Honorable Board reviewed the request from SLO County about amending the CSA 1 agreement to allow additional units to be served by the District sewer treatment facility. The Board tabled this item and requested that a representative from SLO County Engineering Dept. be present to discuss this matter and that Exhibits B & C were missing and would like copies of them.

The County is doing a feasibility study about connecting CSA 1F and other non-connected septic tank systems to their infrastructure which in turn would have the effluent pumped to the District's system. It is the District's understanding that this feasibility study has been completed and has requested a draft of this report.

In reviewing the number of Dwelling Unit Equivalents in the Amendment No. 3 of the Service Agreement, it was found there was one unit counted twice, therefore, the total number has been reduced from 502 to 501.

RECOMMENDATION

It is staff's recommendation that the attached amendment to the Sewer Service Agreement be approved as amended.

COUNTY SERVICE AREA NO. 1 SEWER SERVICE AGREEMENT

ITEM

San Luis Obispo County Service Area No. 1 is requesting the District to provide sewer service to Tract 2196 in Galaxy Park.

BACKGROUND

The District, in developing the sewer project in the mid 80's, executed an agreement with the County in 1984 for construction, operation, and maintenance of the Nipomo Sewer Project which included an outside District boundary agreement to provide service to County Service Area No. 1 (CSA-1). The agreement allowed 327 services in which their wastewater will be delivered to the District for treatment. The agreement has been amended to allow People's Self Help Housing to receive service. Recently, the Regional Water Quality Control Board has requested that the CSA 1-F on-site sewer disposal system be connected to the area-wide sewer system to treat its wastewater. The County is presently doing a study to comply with the Regional Water Quality Control Board's request. To allow service to CSA 1-F, the existing agreement will have to be amended for the additional 60+ units to be served. The developer of Tract 2196, an 11-lot subdivision within the Galaxy boundary, has requested the County for service in which the County is requesting that a separate agreement be entered into to allow the 11-lot subdivision to go forward and be constructed in which this wastewater would be delivered to the District for treatment.

Staff believes that a single amendment to the agreement could be made to cover all the areas of the County Service Area. Such an agreement is attached in draft form. Due to hydrogen sulfide gases, which deteriorates concrete manholes, an additional sentence has been added to paragraph 4 to address this problem.

Attached for the Board's review is a copy of the original Nipomo Sewer Service Project Agreement dated 1994, a map showing different areas of County Service Area 1 (includingCSA 1F, 1, 1A and Tract 2196) and CSA 1F time schedule for connecting to the District system.

RECOMMENDATION

It is staff's recommendation that the attached amendment to the service agreement be approved as amended.

The following is in response to your letter of March 3, 2000 regarding the proposed Amendment No. 3 to the "Service Agreement Between San Luis Obispo County and Nipomo Community Services District for the Construction, Operation, and Maintenance of the Nipomo Sewerage Project".

Per your request the following materials are attached: 1) Exhibit B (Tract 2196 tract map) and 2) Exhibit C (County Conditional Intent to Serve Tract 2196 Letter dated January 26, 2000). It is my understanding that you now have a copy of Exhibit A (above referenced Service Agreement).

County staff are in agreement that Paragraph No. 3 of the proposed agreement should be changed so that the maximum number of units covered by the Service Agreement is 501 instead of 502.

In response to your reference to Article 5, Paragraph C of the original agreement, we recognize your concerns regarding failing septic systems. The study currently being conducted is addressing the responsibilities of the County Health Department, County Planning, and County Engineering, as well as the infrastructure that needs to be installed to serve properties in CSA 1 that cannot now be served. The study will provide recommendations on how the various County departments should respond to failing systems.

In response to your request for a copy of the draft study, we do not believe that would be appropriate. As you know, draft documents are not public records and it is important for all agencies to review the work of their consultants, and accept that work, before making that work available for public review. Nevertheless, we have directed our consultant to meet with you to discuss and understand concerns of the Nipomo Community Services District. We understand that he has done so on several occasions, and if there are any specific issues that you remain concerned on, please identify those issues so that we can make sure that they are addressed. We believe that your concerns are addressed, which includes those that you identified in the proposed Amendment No. 3 to our agreement.

Finally, County Engineering staff will be present at your Board's March 15th meeting during your Board's discussion of this agreement, as you requested. Please provide me with a copy of the agenda and the staff report for this item prior to the meeting date (fax 781-1229).

Dear Doug:

Pursuant to our conversation earlier today, I am sending you a copy of Alpine's lease for your review and approval. The following business terms represent the major points of the lease:

- Initial 5 year lease term with five (5) five-year options to renew, for a total lease term of thirty (30) years.
 - \$7,200.00 annual rent, paid in monthly installments.
 - Rental increase of three percent (3%) per year.
 - Utilities paid by Alpine.
 - Maintenance of Alpine's facility paid by Alpine.
 - Alpine allowed access to its site 24 hours per day/7 days per week.
 - Alpine's architectural plans to be approved by you prior to construction of the site.

As we discussed, Alpine desires to install 4 foot panel antennas attached to the railing at the top of the water tank. They need three clusters of 3 antennas per cluster (each cluster sends the signal a different direction). The antennas will be painted to match the color of the existing water tank. There will also be cables run up the side of the water tank (all in one cluster) that will be painted to match. Alpine will require approximately 100 - 200 square feet of ground space for its 2 equipment cabinets and 1 electric meter pedestal. All of these design requirements will be discussed jointly with Nipomo CSD at next **Tuesday's (1/18) on-site design meeting at 8:30 a.m.**

Please note that the entire site development process is intended to be at no cost, liability or inconvenience to Nipomo CSD. JM Consulting Group and Alpine PCS will handle the entire approval and permitting process with the County of San Luis Obispo, as well as the design and construction management of the site.



Q. What is PCS?

A. Personal Communications Services (PCS) represents the latest advancement in digital wireless telecommunications. This broad family of wireless services consisting of voice, data, and video applications allows users to communicate virtually anytime and anywhere. PCS empowers the user to customize these services to meet his or her individual lifestyle.

Q. What is broadband PCS?

A. This newly emerging wireless offering unlike traditional cellular is 100% digital. Digital technology makes for a much more efficient use of the radio frequency spectrum allowing for other services such as messaging, caller ID and voice-mail to be used on the same handset. The term "Broadband" refers to the size of spectrum allocated by the FCC. The A, B, and C Block auctions licensed 30 MHz and the D, E, and F block auctions will be for 10 MHz of Spectrum.

Q. What is narrowband PCS?

A. The FCC reserved the 930-931 MHz band for narrowband PCS services. This newly emerging wireless offering currently takes the form of wireless messaging or paging. SkyTel's Two-way paging, and PageNet's VoiceNow mobile answering machine are two examples of new applications for the narrowband frequencies. Other services like acknowledgement paging are just around the corner. The term "Narrowband" refers to the size of spectrum allocated by the FCC. The nationwide and regional narrowband auctions for spectrum were for 1 MHz of spectrum as opposed to 30MHz or 10MHz for the broadband auctions

Q. How does a broadband PCS phone differ from a traditional cellular phone?

A. Technologically the principles of each are similar, however, PCS has several advantages over existing cellular. These advantages include better service quality through use of digital technology, enhanced service features, and anticipated lower service costs to the user. The combination of advanced digital technology and encryption capability creates a more secure network for wireless communications. In addition, the cell sites are smaller and closer together providing for a stronger signal and lower power requirements, better in-building reception and fewer dropped calls. Additionally, benefits of broadband PCS over cellular include smaller, lighter handsets and longer battery life.



Q. Can PCS Roam?

A. Yes. PCS has the ability to roam however roaming will not be offered until other PCS license holders roll-out their systems and roaming agreements are negotiated. The North American Interest Group of the GSM MoU is currently working to develop a multi-frequency phone for global roaming

Q. How can I get one? ... and how much?

A. Currently there are three brands of PCS phones on the market: Ericsson, Nokia, and Motorola. The price for a PCS handset ranges from \$159.00-\$199.00. Sprint Spectrum in the Washington/Baltimore area was the first PCS carrier to offer service, followed by Western Wireless in Hawaii. Sprint Spectrum's base offering includes 15 minutes of talk time, numeric paging, voice-mail, and caller ID for their base rate service at \$15.00 per month (no service contract and no credit check is required).

Q. What is the future of PCS?

A. Now that the A, B, and C block auctions are over the United States is covered by 109 licensees. Roll-out of their systems will continue in 1996 and progress through 1997, and 1998. These new carriers will continue to add enhanced features as they are developed. Some of these enhancements may include, new roaming features and wireless internet access.

REQUEST FOR PROPOSALS - MONTECITO VERDE II

ITEM

Request for engineering design to connect MVII on-site sewer system to District system.

BACKGROUND

The staff is requesting engineering proposals to design a connection system at Montecito Verde II on-site septic tank system to the District's sewer system.

Montecito Verde II was developed just prior to the District area-wide sewer system being constructed and therefore was built with on-site sewer disposal facilities for its wastewater. Montecito Verde II onsite wastewater system consists of five separate septic tank systems collecting between 4-10 homes per septic tank and disposal field. Over the years the hydrogen sulfide gases have attacked the concrete to the point where these structures are beginning to fail.

The District has received a letter from the Regional Water Quality Control Board requesting that the District move ahead to connect Montecito Verde II to the District's system and abandon the existing on-site disposal systems. To this extent, an engineering service needs to be acquired to design the connection system. A request for proposals is being presented to your Honorable Board.

Attached is a copy of the Request for Proposals for the Board's review.

Methods of funding


Montecito Verde II presently has approx. \$50,000 in reserves which could pay for the engineering design to connect it to the District's collector system. Funding of the improvements could come from the following:

- Community Block Grant Funding The District has filed an application with the County for Community Block Grant Funding in the amount of \$200,000.
- A number of existing lots that are used for the disposal of the on-site waste, which when abandoned, revert back to the People's Self Help Housing Corporation. If PSHH desires to sell these lots, they could pay for the bulk of the improvements.
- Local Funding via assessment district or loans.

RECOMMENDATION

Staff recommends that the Board authorizes staff to request proposals for engineering services with respect to connecting Montecito Verde II to the District's area-wide sewer collector system.

- I. The Nipomo Community Services District is requesting proposals to design a sewer collector system to connect to a 35-lot subdivision, Montecito Verde II, to the District's sewer collection system. Montecito Verde II (MVII) presently has five separate sewer collector systems with five on-site disposal areas. Some of these on-site systems are showing signs of failure.
- II. Cannon Associates in 1994 did a preliminary design concept to connect MVII to the District system in which they developed the On-Site Layout and Options 1 & 2. Option 3 is another alternative that may take less right-of-way and would be similar to Option No. 1.

Attached are the following sketches:

- MVII location
- MVII existing sewers
- MVII on-site layout and options
- Exhibit showing options

SCOPE OF WORK

- 1. Review the existing options or develop other options to connect the on-site system to the District sewers.
 - a. <u>Option 1</u> Connect MVII to gravity system from Nipomo Palms Lift Station to MVII to Story Rd. sewer line. Abandon Nipomo Palms Lift Station.
 - <u>Option 2</u> Connect MVII to gravity system connecting to MVI sewer system. Include a force main from Nipomo Palms to keep sewage solids moving.
 - c. Option 3 Connect MVII to gravity system in Beverly Drive from Nipomo Palms Lift Station to MVII to Story Rd. sewer line. Abandon Nipomo Palms Lift Station.
 - d. <u>Other Options</u> Other suggested options
- 2. Rank your recommendations and state the pros and cons of each.
- 3. Present your recommendations to the Board of Directors.
- 4. Attend a meeting with the residents of Montecito Verde II.
- 5. Prepare plans and specifications to go out to bid based on the Option selected along with an engineer's estimate of construction costs.
- 6. Prepare Initial Study for CEQA compliance and negative declaration.
- 7. Assist the District during the bid process, including answering bidder's questions, attendance at bid opening, reviewing bid packages and making a recommendation to the Board of Directors to award contract.
- 8. If right of way is necessary, the necessary engineering services will be negotiated as a separate itern.

- 2. Camera Ready copy of the bid package







This is a request for an "Intent to Serve" letter for the enclosed Tentative Tract Map. A tract map number has not been assigned to the project at this time. I will inform you once a number is assigned. The map is in the process of being submitted to the County of San Luis Obispo. The County requires that letters from the various utility companies be submitted to them stating that service to this property is available. We would also request a list of homes/properties that still need to be retrofitted per the plumbing retrofit water conservation program. We understand that we will be responsible for the retrofit of 120 homes prior to the issuance of the "Can & Will Serve" letter, but we can proceed with the processing of the Tract Map with the "Intent to Serve" letter.

Review contract amendment with PERS to include Post-Retirement Survivor Allowance and 1959 Survivor Benefits

BACKGROUND

In attending a CAL-PERS Retirement System educational seminar, it was found that the District did not have the Post Retirement Survivor Allowance nor the 1959 Survivor Benefits in its contract with (PERS) California Public Employment Retirement System.

Post Retirement Survivor Allowance

The Post Retirement Survivor Allowance would provide that upon the retiree's death, a part of the employee's monthly allowance would continue to an eligible survivor (spouse) and dependents. PERS performed an actuarial valuation for the Post Retirement Survivor Allowance and determined that the change in the employer contribution rate would be 1.127% per year. This would bring the employer's contribution to 7.958%. There would not be, however, any out-of-pocket cost to the District for this change for seven years due to the excess assets the District has on deposit with PERS. The excess assets were created primarily from legislative changes made by the State on how PERS actuarial valuations were conducted. Currently, the District's contribution rate is 0% and that would be expected to continue for eleven years.

• 1959 Survivor Benefit

The 1959 Survivor Benefit provides a monthly allowance to eligible survivors of members who were covered for this benefit program and died before retirement. This benefit is available for those members who are not covered by federal Social Security (NCSD employees are not covered by Social Security). The benefit levels are as follows:

*Level 1 and 2 are closed for new agency contract amendments after January 1, 1994. Each employee has the option to elect to participate in this benefit. Participation is not mandatory. The cost to the District at Level 4 with all eight employees electing to participate, would be \$25.60 per month or \$307.20 per year.

The procedure for amending the District contract with PERS would be as follows:

- Adopt the resolution of intention to approve an amendment to the contract between PERS and the District, attached.
- The 1959 Survivor Benefits will be by employee election. Each employee will elect whether he/she wishes to participate in the program or not. The employee election forms with a resolution approving the amendment will be brought back to your Honorable Board for review and finalization.
- Adopt the Final Resolutions at a future meeting.

Having these benefits may assist the District in hiring new employees.

RECOMMENDATION

Staff recommends that the Board adopt the attached Resolution of Intention to Participate in the Post Retirement Survivors Allowance and the 1959 Survivors Benefits.

AMENDMENT TO CONTRACT

Between the Board of Administration California Public Employees' Retirement System and the Board of Directors Nipomo Community Services District

The Board of Administration, California Public Employees' Retirement System, hereinafter referred to as Board, and the governing body of the above public agency, hereinafter referred to as Public Agency, having entered into a contract effective October 1, 1975, and witnessed August 13, 1975, and as amended effective April 22, 1999 which provides for participation of Public Agency in said System, Board and Public Agency hereby agree as follows:

- A. Paragraphs 1 through 11 are hereby stricken from said contract as executed effective April 22, 1999, and hereby replaced by the following paragraphs numbered 1 through 11 inclusive:
 - 1. All words and terms used herein which are defined in the Public Employees' Retirement Law shall have the meaning as defined therein unless otherwise specifically provided. "Normal retirement age" shall mean age 55 for local miscellaneous members.
 - 2. Public Agency shall participate in the Public Employees' Retirement System from and after October 1, 1975 making its employees as hereinafter provided, members of said System subject to all provisions of the Public Employees' Retirement Law except such as apply only on election of a contracting agency and are not provided for herein and to all amendments to said Law hereafter enacted except those, which by express provisions thereof, apply only on the election of a contracting agency.

- 3. Employees of Public Agency in the following classes shall become members of said Retirement System except such in each such class as are excluded by law or this agreement:
 - a. Employees other than local safety members (herein referred to as local miscellaneous members).
- 4. In addition to the classes of employees excluded from membership by said Retirement Law, the following classes of employees shall not become members of said Retirement System:

NO ADDITIONAL EXCLUSIONS

- 5. The percentage of final compensation to be provided for each year of credited prior and current service as a local miscellaneous member shall be determined in accordance with Section 21354 of said Retirement Law (2% at age 55 Full).
- 6. Public Agency elected and elects to be subject to the following optional provisions:
 - a. Section 20965 (Credit for Unused Sick Leave).
 - b. Sections 21624, 21626 and 21628 (Post-Retirement Survivor Allowance).
 - c. Section 21574 (Fourth Level of 1959 Survivor Benefits).
- 7. Public Agency, in accordance with Government Code Section 20834, shall not be considered an "employer" for purposes of the Public Employees' Retirement Law. Contributions of the Public Agency shall be fixed and determined as provided in Government Code Section 20834, and such contributions hereafter made shall be held by the Board as provided in Government Code Section 20834.
- 8. Public Agency shall contribute to said Retirement System the contributions determined by actuarial valuations of prior and future service liability with respect to local miscellaneous members of said Retirement System.
- 9. Public Agency shall also contribute to said Retirement System as follows:
 - a. Contributions required per covered member on account of the 1959 Survivor Benefits provided under Section 21574 of said Retirement Law. (Subject to annual change.) In addition, all assets and liabilities of Public Agency and its employees shall be pooled in a single account, based on term insurance rates, for survivors of all local miscellaneous members.

- b. A reasonable amount, as fixed by the Board, payable in one installment within 60 days of date of contract to cover the costs of administering said System as it affects the employees of Public Agency, not including the costs of special valuations or of the periodic investigation and valuations required by law.
- c. A reasonable amount, as fixed by the Board, payable in one installment as the occasions arise, to cover the costs of special valuations on account of employees of Public Agency, and costs of the periodic investigation and valuations required by law.
- 10. Contributions required of Public Agency and its employees shall be subject to adjustment by Board on account of amendments to the Public Employees' Retirement Law, and on account of the experience under the Retirement System as determined by the periodic investigation and valuation required by said Retirement Law.
- 11. Contributions required of Public Agency and its employees shall be paid by Public Agency to the Retirement System within fifteen days after the end of the period to which said contributions refer or as may be prescribed by Board regulation. If more or less than the correct amount of contributions is paid for any period, proper adjustment shall be made in connection with subsequent remittances. Adjustments on account of errors in contributions required of any employee may be made by direct payments between the employee and the Board.

<u>Bill Status</u>

The last day for bills to be introduced this session was February 25, 2000 – and it was not a deadline that went by unnoticed with the introduction of hundreds of new pieces of legislation. On Friday, March 3, 2000, the CSDA Legislative Committee met and went through a stack of bills close to a foot high. The Committee took a watch position on a number of the bills as many are "spot bills" – placeholders stating legislative intent while awaiting the final drafting of the author's language. In addition, many of the bills were recently introduced and the Committee/Legislative Advocate Ralph Heim will be seeking further clarification prior to taking a position. AB 1396 (Villaraigosa) – This bill will be the vehicle for the Speaker's Commission on State and Local Government Finance. This Commission's report is in its final stages and should be printed within the next few weeks. If you are interested in viewing the Commission's recommendations they are available on the following website location <u>www.speaker.metroforum.org</u>.

AB 2838 (Hertzberg) – This bill includes the recommendations from the Commission on Local Governance for the 21st Century. The 243-page bill is being discussed in detail by a Task Force called together by "soon-to-be Speaker" Assembly Member Hertzberg of which CSDA Legislative Advocate Ralph Heim is a participant. CSDA has taken a "support with amendments" position on the report and bill.

A Joint Conference Committee is being established in the Legislature to review all of the recent reports on state/local government finance and structure. Senators Peace, Poochigian and Perada appear to be the selected Senate members. The Assembly representatives have not yet been identified. CSDA will closely follow the activities of the Joint Committee and keep members informed of the discussions.

Retirement – A handfull of bills have been introduced that deal with public employees retirement benefits. A subcommittee has been established by the Legislative Committee to review these specific bills and report back with recommendations.

The next meeting of the CSDA Legislative Committee is scheduled for April. CSDA will report on any amended and established positions at that time.
