District Legal Counsel has prepared an outline of the committee's recommendations for your review and consideration.

# I. CONSIDERATIONS: ANNEXATION AND SUPPLEMENTAL WATER

- A. The District receives most of its water from the Nipomo Mesa Hydraulic Sub-Area ("HSA").
- B. The HSA is part of the Greater Santa Maria Groundwater Basin. Both the HSA and the Santa Maria Groundwater Basin along with agricultural users, private parties and local water agencies (including the District) are subject to a general Groundwater Adjudication.
- C. Many of the Applicants who seek annexation to the District are parties to the Groundwater Adjudication, whose interests may be adverse to the District and whose water entitlements are the subject of future Court Judgments.
- D. The Court may impose restrictions on the District's ability to pump groundwater from the HSA to serve District residents.
- E. District acknowledges a number of engineering reports indicating that HSA is in a state of overdraft.
- F. The District desires to maintain a water supply for its existing users and potential users within the District boundaries.
- G. It is the District goal to provide its current residents with low cost, dependable water, sewage and other authorized services within the District.
- H. The District recognizes the need for conservation of natural and environmental resources, including local resources, their availability and quality, consistent with the South County General Plan of the San Luis Obispo County.

- I. Proposed annexations must provide identifiable benefits to:
  - 1. The residents and property owners currently within the Nipomo Community Services District; and
  - 2. The future residents and property owners within the area of the proposed annexation.
- J. The District recognizes two (2) general classes of proposed annexations as follows:
  - 1, Those areas of proposed annexation that overlie the HSA and have sufficient water resources to serve the proposed area of annexation; and 2. Those areas of proposed annexation that <u>do not</u> overlie a sufficient source of groundwater to serve the area of proposed annexation.

# II. THE BOARD OF DIRECTORS INTENT

Annexations shall provide and pay for supplemental water for the area of annexation as a condition of District approval.

III. DRAFT POLICIES - SUPPLEMENTAL WATER - AREAS
OVERLYING sufficient groundwater resources\*\* See dispute
resolution - Section G below

- A. Dedications and Covenants:
  - 1. Proponents shall dedicate groundwater rights, if any, to the District;
  - 2. Proponents shall covenant not to pump from the HSA for non-agricultural uses.
  - 3. Properties may continue to pump from the HSA for agricultural uses subject to any limitations imposed by Court or other agency with jurisdiction.
- B. Up Front Financial Obligations:

At the time of entering into the Annexation Agreement make deposit for District administrative, consultant and legal costs in processing the annexation (per existing Policy);

# C. Financial Obligations Prior to LAFCO Approval:

- Deposit with the District ten thousand dollars (\$10,000) per water connection to be applied to District administrative and consultant costs in acquiring supplemental water and to offset costs of supplemental water\*.
- 2. Pay District water capacity charges reduced by that portion attributed to well production\*.
- \* Returned if LAFCO does not approve annexation. Further, to the extent the supplemental water deposit exceeds District's costs, as prorated among other applicants for annexation, the remainder will be used to reduce Section D water charges. District to enact Ordinance related to water charges.
- D. Payment of Monthly Supplemental Water Charge:

Proponents shall agree to establish a zone of benefit with a rate covenant wherein those residents within the zone will pay eighty percent (80%) \* of the actual costs of supplemental water for the area of proposed annexation plus one hundred percent (100%) of the reserve that may be required to obtain supplemental water.

\*Equitable adjustment to reflect Paragraph E below.

E. Customers of the District:

- 1. Upon annexation, residents within the area of the proposed annexation shall become "regular customers" of the District with no greater entitlements to water service than any other District customer.
- 2. Subject to compliance with the Annexation Agreement, LAFCO conditions, District Public Facilities Extension Agreement and availability of water, District agrees to provide water to the area of annexation upon LAFCO final approval.
- F. Cluster Developments:
  - 1. Dedicate open space to District for an identified purpose approved by District and which may be operated by District. \*.

- 2. If the District accepts responsibility for the open space then applicant shall form an Assessment District or other Special Tax District for the purposes of the operation and maintenance of the open space.
- 3. Create a Homeowners Association for the purposes of assuming obligations in Subparagraph 2 above in the event the District is required to abandon the Assessment District or Special Tax.
- \* May require exercise of Latent Power.
- G. Dispute Resolution:

If applicant disputes District determination that the area of proposed annexation <u>does not</u> overlie a sufficient groundwater resource, then applicant, at applicant's sole cost, may request District to perform a pump test to the District Engineer's standards. The Board of Director's determination of the sufficiency of the groundwater supply shall be final.

# IV. DRAFT POLICIES – SUPPLEMENTAL WATER - AREAS OF ANNEXATION THAT <u>DO NOT</u> OVERLIE A SUFFICIENT GROUNDWATER RESOURCES

- A. The proponents will comply with all conditions set forth in Section III for proposed annexations that overlie the groundwater basin;
- B. Pay one hundred percent (100%) of the monthly supplemental water charge (see III D above); and
- C. District will not deliver water to the area of annexation until:
  - 1. A sufficient supplemental water is under contract; and
  - 2. CEQA review, including challenges, are completed; and
  - 3. The Board determines that there is sufficient water to serve the proposed area of annexation during the construction phase.

# V. STATE WATER

The Board will not acquire State Water as a supplemental water supply without first obtaining the approval of the District voters.\*

\*Note the Court <u>may</u> have jurisdiction to order State Water as part of the Adjudication Resolution.

### SEWER HOOK-UP OF EXISTING RESIDENTIAL PROPERTIES

### ITEM

Regional Water Quality Control Board letter requesting all homes within the Prohibition Zone be connected to the sewer system

### BACKGROUND

In the mid eighties, the District received an 871/2% grant to construct the District's area-wide sewer collector and wastewater treatment facility. Part of the conditions of the grant program was that all homes within the Prohibition Zone (where sewer lines are available) would be connected to the sewer system within a ten (10) year period. There was some confusion in the inventory of the number of homes to connect. It was determined that one thousand (1000) homes connected would satisfy the grant program. At the end of the tenth year, the District satisfied the 1000 connections to the sewer system. In a recent inventory, it was discovered that approximately 70 to 80 homes have not connected to the sewer system.

The Regional Water Quality Control Board has sent a letter to the District that the District comply with the intent of the original grant and that all homes should be connected to the sewer system. The homes that are not connected are primarily east of Highway 101.

The following may be considered to comply with the request from the Regional Water Quality Control Board:

- Send a letter to property owners giving a period of time to connect to the sewer system.
- Those property owners, who may have a financial hardship to connect, may be able to receive assistance through Farmer's Home Administration Financial Programs or create a "Zone of Benefit"
- The property owners who have not connected their property to the sewer system, after a period of time would be reported to the RWQCB for appropriate enforcement action.

# RECOMMENDATION

Staff is asking for direction from your Honorable Board how you wish to proceed.

# NIPOMO COMMUNITY SERVICES DISTRICT – FULL HOOKUP REQUEST, SAN LUIS OBISPO COUNTY.

We are in receipt of a letter dated November 5, 2002 prepared by Shipsey & Seitz, a law firm that represents the Nipomo Community Service District. In the letter you request: "the Regional Water Quality Control Board to commence action to connect the referenced properties to the wastewater treatment system consistent with Resolution 78-02".

As noted above, in 1978, Resolution No. 78-02 was adopted by the Regional Water Quality Control Board in response to health threats in and around the downtown Nipomo area. The threats encountered were due to surfacing leachfield effluent from failing systems and water quality and public health impacts (pathogens) detected in nearby water supply wells. That resolution established a prohibition zone banning individual wastewater treatment systems in the more densely populated sections of Nipomo (Attachment A). The original grant conditions, which provided the funding for the treatment plant, required 100% hookup within a ten-year period for all homes in the prohibition zone. That 10-year period ended in April of 1997, yet a significant number of homes within the established prohibition zone are still not connected to the Nipomo Community Services District (NCSD) wastewater treatment facility. These unconnected homes not only continue to present a threat to water quality and human health, but they also create an inequitable situation for those residents who did comply with the requirements in a timely manner. Of the homes (80 downtown and approximately 70 within the Galaxy Park development) that have still not connected to the collection system, no requests for exemption or explanations for noncompliance were received by the Regional Board. Furthermore, no explanation has been provided to us why the NCSD has not proceeded in notifying and making preparations to hookup these remaining homes.

It has been five years since the hookup deadline and we must now actively pursue the compliance of those remaining homes and developments within the Nipomo prohibition zone. As the public entity formed for the purpose of supplying acceptable quality water supply and wastewater disposal to the community of Nipomo the NCSD has the responsibility to make an active effort to notify and inform those residents of the requirement to connect to the NCSD collection system and cease discharges in violation of this Regional Board's Basin Plan Prohibition. In addition, the NCSD is responsible for preparing design plans, ensuring that the proper environmental, financing, and permitting documents are in place to complete the project.

Please provide by **June 30, 2003**, a report listing actions taken, timeline for hookup, and progress made toward completing this project.



### CONSTRUCTION OF 16-INCH WATERLINE REQUEST FOR BIDS

# ITEM

Request bids to complete 16" waterline across Haystack Creek in Tefft Street and install water and sewer services to the parcels along Tefft Street in Olde Towne Nipomo to be funded by a County grant

# BACKGROUND

The District has had a 16-inch waterline constructed from Dana Elementary School to Thompson Avenue, except for a section across Haystack Creek. The County is planning to construct a new culvert across that section in conjunction with the Olde Towne Nipomo improvements. After the new concrete diversion channel has been constructed, the existing channel will be filled in. After this work is completed, the District will have the 16" waterline construction across this area.

The installation of the water and sewer services in Olde Towne Nipomo may be made in conjunction with the District's 16" waterline completion project, using the same contractor.

Bids will include the following:

- Completion of the 16-inch waterline
- Installation of water and sewer services to individual properties in conjunction with grant funding from SLO County
- Possible installation of fire line services

The District would front the installation cost of the services until the grant funding is received this fall. The grant, in the amount of \$186,300, will be remitted to the District to cover the cost of the installations. Staff would recommend not proceeding with the installations of the water and sewer services until the grant agreement has been reviewed and approved by your Honorable Board.

# RECOMMENDATION

It is recommended that your Honorable Board direct staff to request bids for the completion of the 16-inch waterline and installation of water and sewer services to properties along Tefft Street in the Olde Towne section of Nipomo conditional on approving the grant agreement.

At the request and expense of the Contractor, surety equivalent to the retention may be deposited with the State Treasurer or a State or Federally chartered bank as the escrow agent, who shall pay such surety to the Contractor upon satisfactory completion of the contract.

Surety eligible for investment shall include that listed in Section 16430 of the STATE GOVERNMENT CODE or bank or savings and loan certificates of deposit.

Any escrow agreement entered into shall contain the following provisions:

- (a) The amount of surety to be deposited;
- (b) The terms and conditions of conversion to cash in case of default of the Contractor, and
- (c) The termination of the escrow upon completion of the contract.

**Discussion:** This status report is to bring the Commission up-to-date with regard to the Sphere of Influence Update and Municipal Service Review being prepared for the Nipomo Community Services District.

Staff continues to meet with representatives of the County Planning Department and with the General Manager of the Nipomo Community Services District to discuss the study areas. Also, a meeting between the County Public Works Department and the NCSD staff to discuss the consolidation of CSA 1 was facilitated by LAFCO.

**Public Outreach.** To obtain information and feedback about the eight study areas, a flyer describing the Sphere of Influence process, the map, and a request for comments form were mailed to various community organizations and interested individuals. The flyer, comment form, and map are also available on the LAFCO website <u>WWW.SLOLAFCO.COM</u>. Comments are due back on March 17, 2003. The Study Area Map has generated a good deal of e-mail discussion regarding the Study Areas and we are gaining valuable insights and information about the areas being considered for inclusion in the SOI. To inform and involve the public and various stakeholders in the SOI/MSR process, LAFCO staff will be making presentations to the Nipomo Community Advisory Committee (March 24, 2003-6:30 p.m.) and the Save the Mesa group (April 5, 2003-2:30).

**Tour of the Study Areas.** Attached is an itinerary and map that shows the bus tour planned for today's meeting. The meeting will be adjourned to the Tour, which will start with a brief orientation meeting at the NCSD's office. The itinerary shows the **estimated times** we expect to be in certain Study Areas. Every attempt will be made to adhere to the itinerary; however we may be early or late to the study areas. The bus has enough room for 22 people and the public is invited to ride on the bus if space is available. The public may follow the bus or meet us at various sites as space is limited on the bus.



#### PROPERTY TAX EXCHANGE FOR PROPOSED ANNEXATION NO. 22 40 ACRES (SUNDALE AND DAWN ROAD) PUDWILL

#### BACKGROUND

The District has received a request to annex Tract 2684, a 40 acre development at Sundale and Dawn Road. This proposed annexation is being processed through LAFCO.

With any proposed annexation to the District, the State Revenue & Taxation Code Section 99 requires the District and the County to negotiate the property tax exchange for the property being annexed into the District. Different areas have a slightly different tax rate percentage with respect to taxation. Therefore, an average of the area around the proposed annexation was taken. The percent of property tax increment that would be transferred to the District for Annexation No. 22 would be 6.05086%.

If the proposed annexation does not proceed, the Resolution approving the property tax exchange becomes null and void.

Attached is Resolution No. 03-tax exchange is presented to your honorable Board for consideration.

#### RECOMMENDATION

Staff recommends that your honorable Board adopt Resolution No. 03-tax exchange accepting the SLO County/NCSD exchange of property tax revenues and annual tax increments for Annexation No. 22 at 6.05086%.
