# ITEM

Award contract to repair road damage on Bracken Lane created by broken water line

# BACKGROUND

On October 7, 2003, ARB, Inc. was installing a gas service for The Gas Company at 812 Bracken Lane when their boring equipment struck a District water line. The impact of the boring equipment split the water line flooding Bracken Lane and undermining the existing road. ARB, Inc. was contacted about making the repairs but did not respond.

The District has requested bid proposals to repair the road damage. The cost comparison for the road repair is on a square footage basis.

M J ROSS	\$2.69 sq/ft
Advance Design	\$3.00 sq/ft.
APODACA	\$3.06 sq/ft

A contract has been prepared to award the contract to MJ Ross to repair the road in the amount of \$19,500. An amount of \$20,000 was previously approved to fund this project. The District will seek reimbursement from ARB, Inc.

Staff recommends that your Honorable Board approve awarding the contract to MJ Ross to repair the road on Bracken Lane in the amount of \$19,500.
