BACKGROUND

ITEM

Authorize execution of agreement with Ground Up Construction to perform construction management services for Black Lake WWTF Liner Replacement Project [RECOMMEND ADOPTION].

BACKGROUND

On April 10, 2007 staff mailed out five "Request for Proposals" (RFPs) regarding Construction Management Services for the Black Lake WWTF Liner Replacement Project to the five firms pre-qualified to perform Construction Management Services for the District. Four firms responded by the May 10, 2007 deadline with Ground Up Construction submitting the lowest cost quote. Attached is a summary of the four quotes and a copy of Ground Up's submittal.

It should be noted that staff is negotiating with Garing Taylor and Associates regarding provision of Engineering Services During Construction (ESDC). GTA's proposal will be submitted for separate consideration.

RECOMMENDATION

Staff believes that Ground Up's proposal is responsive and Ground Up performed well in managing the Hetrick Project. Staff recommends that your Honorable Board authorize staff to execute a Task Order for Ground Up to perform the services set forth in the attached proposal on a time and materials basis with a not to exceed expenditure limit of \$10,600.

Ground Up Design & Construction Management (GU) has reviewed your "Request for Quote for Construction Management Services" and is pleased to following information:

Introduction and Understanding: The Nipomo Community Services District (NCSD) intends to replace the existing pond liner at the Black Lake WWTF. The plans have been developed by Garing & Taylor and Associates and are to be presented to the NCSD Board in late April or early May. The District anticipates that the Construction Manager will perform a plan check and constructability review prior to the plans being placed out to bid.

The project is expected to bid in June 2007, start construction in July 2007 and be completed by September 2007. The project budget is estimated at \$175,000.00.

The District is seeking a Time & Materials Not to Exceed Quote for Construction Management Services as outlined in the original RFP and in conformance with the project description provided in the RFQ.

The requirements of this specific project will be to provide a plan check / constructability review and review the cost estimate provided by Garing & Taylor Assoc. (G&T), assist with the bid proposal process, assist the District with verification of contractors bonds and insurance, assist in the Notice to Proceed process, perform the pre-construction meeting, provide submittal

management and then perform the day to day construction management and inspection of the project. Based on discussions with GTA staff, Bruce Buel, and the project budget we anticipate the construction duration to be approximately 25 working days.

GU takes no exceptions to the attached listing of services or the agreement and will assemble the costs for surveying and soils engineering services as required for the project as soon as the plans are available to provide to consultants for quotes.

The Construction Inspector and Construction Manager for this project will be Robert W. Carnes, his resume and background information was provided in the SOQ.

Fee: Based on my discussion with GTA Staff and Bruce Buell pertaining to the project and the construction time frame as provided in the RFQ we anticipate providing the following services with hours as shown:

- 1. Constructability plan review, 8 hours.
- 2. Construction Cost Estimate review, 8 hours.
- Bid Administration and Assistance, 10 hours.
- 4. Construction Contract Management and Inspection (3 hours per day during construction activities (approx. 5 weeks)), 75 hours.
- 5. Administration Time is calculated as a percentage of total time.

The total hours anticipated for the project are 101 hours. Based on the above information Ground Up's Time & Materials Not to Exceed Fee for Inspection and Construction Management Services is \$10,600.00.

Continue consideration of Chestnut Villas Intent-To-Serve Letter application for mixed use complex at 166 & 186 North Thompson until August 22, 2007 Board Meeting [RECOMMEND ADOPTION].

BACKGROUND

The Board initially reviewed this application at its May 9, 2007 Board Meeting and continued this item to this meeting. The Board on May 9, 2007 directed District Legal Counsel to opine on the discretion available under the law to allocate water to other than Low Income Housing Projects when there was a limitation on available supply. Given District Legal Counsel's determination that Low Income Housing Projects have priority over other projects, staff believes that the Board will need to re-allocate water to fund this project and the Allocation Ordinance restricts such transfers until the middle of the last quarter of the Allocation Year. Thus, the earliest that the Board can consider this project would be the August 22, 2007 Board Meeting.

RECOMMENDATION

Staff recommends that the Board continue this item until the Board's August 22, 2007 Board Meeting.
