### **DISTRICT BUSINESS**

#### **Administrative**

Maria Vista Estates has set a total of ten water meters.

The last day of the 2008 Nipomo Greenwaste Chipping Days was July 3. Staff will provide a wrap up report at the July 23<sup>rd</sup> Board Meeting.

Recruitment is underway to fill the two open Customer Service positions. 54 individuals applied and 9 were invited to interviews on July 7 and 8.

The Board of Supervisors, on June 24, 2008, included funding in their FY08-09 Budget for the County's share of equipping the two additional sentinel wells with monitoring & reporting equipment.

President Winn and Vice President Harrison met with Supervisor Achadjian and representatives of the Woodlands and GSWC on June 25, 2008 to discuss multi-tiered water rate structures. The Woodlands indicated that they currently use a two tiered rate structure and GSWC indicated that they are applying to the PUC to convert to a two tiered rate structure.

Staff has contracted with Hayes Paving to seal the Office parking lot on Saturday July 19 and Sunday July 20. The lot will be closed these two days.
