# Campaign Statement for CSDA Board of Directors

# Tim Ruiz Region 4

I am a lifelong Kern County resident having attended local schools in Bakersfield and eventually earning a Bachelor of Science Degree in Civil Engineering from Cal Poly San Luis Obispo, as well as a professional engineer's license. I have experience working in the private sector as a consultant (with Boyle Engineering Corporation) for over ten years, working on many projects associated with special districts and water agencies. Prior to my years working as a consultant, I worked for the Friant Water Users Authority in Lindsay, California and during the 1980s with the Kern County Public Works Department as an engineering aide on a survey crew. I have been the General Manager for the East Niles Community Services District for just over five years overseeing the management of a public water system and sewer system serving a population of 25,000-30,000. I understand the issues facing special districts concerning tax shifts, having experienced the last round of ERAF shifts a couple of years ago, and having to deal with lost revenues.
