Update and Comparison of Water Consumption

- See attachment Comparison of Water Delivered, 2006 2008.
- Overall, comparing years 2006, 2007 and 2008, for the months of January through October, there was a decrease in water use in 2008. This may be due to the markedly increased precipitation in 2008.
- The percentage of water use per category to total water use for the District remains relatively unchanged, with the SFR category accounting for the lion's share of water consumed, and the Ag category accounting for the amoeba's share of water consumed.

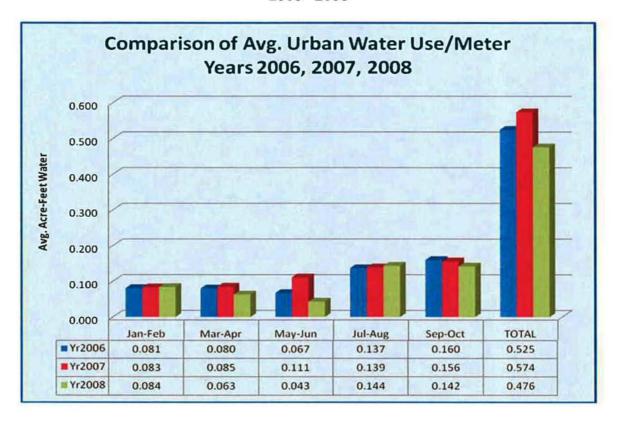

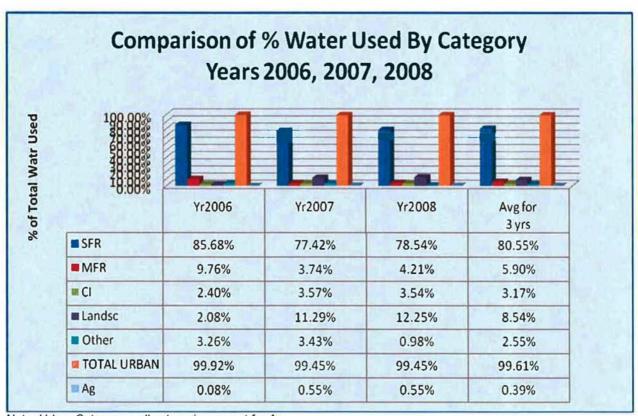

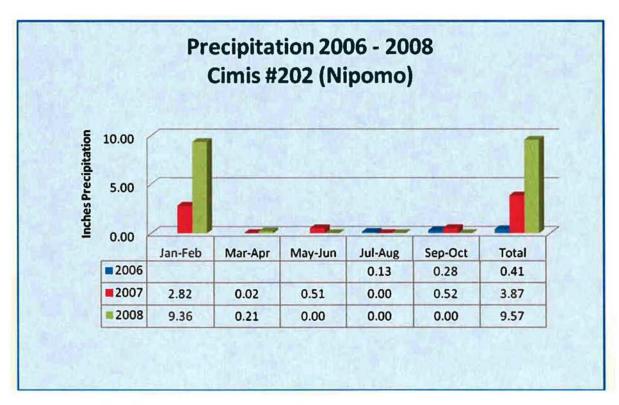

The Project Team has completed the following work items this month:

- Most of the survey field work and all of the aerial mapping has been completed. Preliminary
 mapping has been completed for the well sites, Blosser Road, the Santa Maria River crossing,
 and the proposed pipeline alignment on the mesa between the bluff and Joshua Rd.
- 2. Geotechnical field work has been completed. Concrete pavement was discovered along Oakglen Avenue and Darby Lane and Fugro is preparing a budget revision request to collect core samples in order to determine the thickness of the pavement. This is recommended since it will allow the contractors to provide more accurate bids for sawcutting and removal. It is our understanding other concrete pavement may be present along Frontage Road and we are working with County staff to identify these locations.
- Property negotiation for the pipeline easements, tank site, and pump station site between the bluff and Joshua Rd is underway. Boyle has provided preliminary site plans to the District for this work.
- 4. The Streambed Alteration Agreement from California Department of Fish & Game for our inriver soil borings required that a qualified biologist provide training and monitoring during the geotechnical drilling work. This line item has been added to the Project Budget as Budget Revision #2.
- Boyle has begun working on a hydraulic analysis to address potential supplemental water turnouts for Golden State Water Company and the Woodlands community. This line item has been added to the Project Budget as Budget Revision #3.

Schedule

The Project Schedule has been updated to reflect the additional mapping, geotechnical investigation, and design services required for the Oakglen Avenue, Darby Lane, and Orchard Road waterlines authorized in Budget Revision #1.

Budget Status

As shown on the attached Design Budget and Invoice Summary, our fee earned matches the amount expended. This indicates we are on budget as of this date.
