ITEM

Discuss development of emergency water shortage regulations [PROVIDE DIRECTION]

BACKGROUND

Your Honorable Board, on June 24, 2009, set this Special Meeting to allow for review of staff's submittal to the NMMA Technical Group at its 7/7/09 Meeting. Staff is still working on its rewrite of the draft regulations, however, staff has developed the attached handout entitled – "Stages, Triggers and Targets" and the attached summary of Director feedback on the 16 Rule 14.1 Components entitled "Rule 14.1 Component Support". Staff hopes to provide a rough draft of proposed regulations to the Board at the Board Meeting.

FISCAL IMPACT

Development of this draft did use previously budgeted staff time and legal consulting cost.

RECOMMENDATION

Staff recommends that the Board review the attached materials, receive staff's presentation and then discuss what should be presented to the Technical Group at its 7/7/09 Meeting.

NMMA Emergency Water Shortage Regulations -- Stages, Triggers and Targets

WATER SHORTAGE STAGES

The NMMA will have three Water Shortage Stages, One Advisory/Voluntary (STAGE 1) and Two Mandatory (STAGE 2 - Potentially Severe Water Shortage Situation and STAGE 3 - Severe Water Shortage Emergency)

TRIGGERS (Transitions between Stages)

Until actual Supplemental Water is available for use within the NMMA, all purveyors shall be at an Advisory/Voluntary Stage (STAGE 1) unless one of the mandatory stages has been declared by the Court and the CPUC.

The Potentially Severe Water Shortage Situation (STAGE 2) shall be declared for all purveyors whenever the Court determines that the NMMA is in a Potentially Severe Groundwater Shortage Situation and the CPUC authorizes Mandatory Rationing.

The Severe Water Shortage Emergency (STAGE 3) shall be declared for all purveyors whenever the Court determines that the NMMA is in a Severe Groundwater Shortage Emergency and the CPUC authorizes Mandatory Rationing.

TARGETS (Demand Reductions)

For STAGE 1 (Advisory/Voluntary Stage) there is no mandatory demand reduction target, however, a goal would be to reduce annual demand by 20% over base year behavior as set forth in AB49 and the Governor's 20x2020 Executive Order. Thus, customers will be asked to reduce total consumption in the four purveyor's service areas from 5,500 afy to 4,400 afy.

For STAGE 2 - Potentially Severe Water Shortage Situation – a target reduction of 25% to achieve a 1,400 afy reduction in total consumption in the four purveyor's service areas from 5,500 afy to 4,100 afy to reduce the annual demand by an amount equal to the average annual overproduction in the management area. The 1,400 afy demand reduction is expected to avoid a drop in groundwater levels that could otherwise allow for declaration of a STAGE 3 situation.

For STAGE 3 - Severe Water Shortage Emergency – a target reduction of 50% to achieve a 2,750 afy reduction in total consumption in the four purveyor's service areas from 5,500 afy to 2,750 afy to reduce the annual demand by an amount equal to the twice the average annual overproduction in the management area. The 2,750 afy demand reduction is intended to raise groundwater levels so as to pull the Management Area out of the STAGE 3 situation.

GENERAL INFORMATION (Continued) Page 2 (N)
6. In the event of a water supply shortage requiring a voluntary or mandatory program, the utility shall make available to its customers water conservation kits as required by its version of Rule 20. The utility shall notify all customers of the availability of conservation kits via a bill insert or direct mailers.
A. CONSERVATION - NON-ESSENTIAL OR UNAUTHORIZED WATER USE
No customer shall use utility supplied water for non-essential or unauthorized uses, including but not limited to:
Use of potable water for more than minimal landscaping, as defined in the landscaping regulated of the jurisdiction or as described in Article 10.8 of the California Government Code in connection with new construction;
 Use through any meter when the company has notified the customer in writing to repair a broken or defective plumbing, sprinkler, watering or irrigation system and the customer has failed to effect such repairs within five business days;
3. Use of potable water which results in flooding or runoff in gutters or streets;
4. Individual private washing of cars with a hose except with the use of a positive action shut-off nozzle. Use of potable water for washing commercial aircraft, cars, buses, boats, trailers, or other commercial vehicles at any time, except at commercial or fleet vehicle or boat washing facilities operated at a fixed location where equipment using water is properly maintained to avoid wasteful use;
 Use of potable water washing buildings, structures, driveways, patios, parking lots, tennis courts, or other hard-surfaced areas, except in the cases where health and safety are at risk;
6. Use of potable water to irrigate turf, lawns, gardens, or ornamental landscaping by means other than drip irrigation, or hand watering without quick acting positive action shut-off nozzles, on a specific schedule, for example: 1) before 8:00 a.m. and after 7:00 p.m.; 2) every other day; or 3) selected days of the week; (N)
