



BACKGROUND

In March of last year the Board reviewed a cost-benefit analysis which included out sourcing preventive maintenance work. The analysis was prepared assuming NCSD would hire two additional Utility Workers and purchase the equipment necessary to perform sewer cleaning, valve and hydrant exercising. The analysis illustrated that it is cost-effective for NCSD to perform this work in-house. A new full-sized truck and new valve exercising equipment were budgeted for purchase to facilitate this work.

Staff has researched the cost of a suitable pick-up truck which would provide support to the preventive maintenance staff while in the field exercising valves and hydrants. It was recommended that we purchase a ³/₄ ton truck to pull the valve-exercising equipment, which weighs approximately 7000 pounds.

Three auto dealers were contacted to provide quotes for a ³/₄ ton F-250 diesel truck: Mullahey Ford of Arroyo Grande, Paso Robles Ford, and Santa Maria Ford. Mullahey Ford has the lowest-priced truck available.

Two companies were contacted to provide quotes for automated valve-exercising equipment, E.H. Wachs, and Pacific Tek. The valve-exercising equipment is trailer mounted, and includes a small vacuum unit with a spoils tank for cleaning sand and debris from valve cans, as well as the valve-operating equipment and data loggers. Both products have the capabilities of storing the data received from the valve-exercising equipment. Both companies provided demonstrations of their product to District staff for evaluation.

District staff operated and evaluated each of the units and prefers the Wachs unit, due to the ease of operability and an additional feature which will greatly reduce valve breakage while exercising our older valves. The Wachs unit has an automation feature which monitors the torque applied to the valve and gradually increases the torque during valve exercising. The torque and number of turns required to exercise the valve is automatically saved in the database. The Pacific Tek unit, while quite similar, does not include this feature.

FISCAL IMPACT

The Fixed Asset Purchases for Fiscal Year 2009-2010 Budget included \$30,000.00 for a full sized pick up and \$50,000.00 for the valve exerciser for a total Budget amount of \$80,000.00.

RECOMMENDATION

The Staff recommends that your Honorable Board approve purchase of the valve exercising equipment from E.H. Wachs Company for \$47,071.69 and the ³/₄ ton F-250 truck from Mullahey Ford for \$30,147.97 for a total amount of \$77,219.66.






