# SUPPLEMENTAL WATER ALTERNATIVES EVALUATION COMMITTEE PRESENTATION OF DRAFT-FINAL REPORT

## ITEM

The Board's Supplemental Water Alternatives Evaluation Committee will deliver and present their draft-Final report [NO ACTION REQUESTED].

#### **BACKGROUND**

On June 27, 2012, your Board approved Bylaws for and the formation of, a citizens' committee, the 'Supplemental Water Alternatives Evaluation Committee' (Evaluation Committee). The District received sixteen applications for membership on the committee from throughout the community. A nomination committee was formed with appoints by 4<sup>th</sup> District Supervisor Paul Teixeira, the District and other area water Purveyors. On August 14, 2012, your Board approved the nomination committee's recommendation for membership on the Evaluation Committee.

The Evaluation Committee is tasked with conducting an evaluation of alternatives for delivering supplemental water to the Nipomo Mesa Water Conservation Area and making a report to your Board on their findings. The Evaluation Committee has seven (7) voting members, a non-voting Chair, and Vice Chair, as follows:

While your Board purposely narrowed the Committee's scope in order to facilitate a reasonable task assignment and timely process, the Committee decided early on to broaden the scope of their effort to include review of water conservation, regional water issues, and a detailed review of all possible alternatives. Despite taking on the additional review, the Committee and each of its individual volunteer members stayed committed to delivering a comprehensive report to your Board in early 2013.

Since the Committee's first meeting in September 2012, the Evaluation Committee has met formally in public Brown-act compliant notice meetings more than ten times. In addition to the hours of full-committee public meetings, members have put in long hours working in sub-committee and individually, researching and analyzing potential water sources and writing up their findings.

The Evaluation Committee met on February 22, 2013 to review and edit their Administrative Draft Evaluation Report. Today, committee members will present the draft-Final report, summarize their process, discuss findings, and answer questions.




