



If you observe a potential leak or observe suspicious activity involving tampering with the SWP Pipeline facilities, we would appreciate a call. We have a pipeline operator on-call 24 hours per day/7 days per week and they can be reached at 805-245-7054.

Please know that our staff will be uniformed and driving marked agency vehicles when accessing the pipeline easement for routine operations and maintenance activities.



Encroachment Permit Program

The SWP Pipeline was constructed within an easement crossing your property. If you have plans to construct something within the easement, an encroachment permit is needed. This is a process of comparing the design for your construction project to the existing locations of the SWP Pipeline facilities. KEYNOTE SPEAKER



California State Controller John Chiang As the Chief Fiscal Officer of California, Controller John Chiang oversees the State's nearly \$100 billion annual budget. He also helps administer the state retirement systems CalPERS and CalSTRS, and serves on 81 State boards and commissions, charged with everything from protecting our coastline to overseeing local government financial reporting.

The Controller's monthly financial reports on state revenue gains and losses are especially sought after throughout the budget adoption process. Appropriately, SDLD is held the same week as the California Budget May Revise is anticipated for release by Governor Jerry Brown.

In addition to being responsible for accounting for and controlling disbursement of all state funds, as well as processing all personnel and payroll transactions for public employees, Controller Chiang has key audit oversight for state and local government programs. These audits have identified more than \$3.5 billion in taxpayer dollars that were denied, overpaid, subject to collection, or resulted in revenues, savings and cost avoidance. As state controller, his audit authority includes ensuring that independent audits of local governments comply with professional audit standards, address discrepancies, and inform the public of financial transactions and compensation.

Controller Chiang was first elected in November 2006 to serve as Controller of the State of California, and was re-elected to serve a second term in November 2010.

LOCAL GOVERNMENT COMMITTEE LEADERS



The Honorable Katcho Achadjian (R-San Luis Obispo) – Chair of the Assembly Local Government Committee, Assembly Member Achadjian represents the 35th Assembly District, which includes the communities of Paso Robles, Pismo Beach, San Luis Obispo, and Santa Maria, among others. Prior to his election to the Legislature, Achadjian served for three terms as an elected member of the San Luis Obispo County Board of Supervisors.



The Honorable Mark Levine (D- San Rafael) – Vice-Chair of the Assembly Local Government Committee, Assembly Member Levine was elected in November 2012 to represent the 10th Assembly District, comprised of the communities of Sausalito, San Rafael, Novato, Petaluma, and Sonoma, among others. A former San Rafael City Councilmember, Levine has held leadership posts throughout his career helping to develop innovative solutions at the local, state, national and international levels.



The Honorable Stephen Knight (R- Palmdale) – Vice-Chair of the Senate Governance and Finance Committee, Senator Knight was elected to the California State Assembly in November 2008 and the State Senate in 2012. Prior to his election to the Assembly, Knight was elected to the Palmdale City Council in 2005. Upon assuming office in the state Legislature, Knight left his 18-year career as a sworn police officer in the Los Angeles Police Department.

Board Allows Applications for New Water Service

In a follow-up from the February 28th, 2013 press release "Board Initiates Process to Allow Applications for New Water Service," the District's Board, during their regular meeting on March 13th at 9AM, unanimously adopted an Ordinance to suspend District policy and allow renewed processing of applications for new District water service.

Processing of applications was previously suspended last spring when funding and the timeline for the supplemental water pipeline project became unsure. With a clear schedule and approved funding plan for bringing in supplemental water from an intertie pipeline with the City of Santa Maria, the Board approved to once again allow applications for new water service. The change becomes effective immediately.

The suspension, versus a full repeal of the previous action, gives the Board flexibility to reestablish the previous policy (of no new water connections) should the circumstances for delivering supplemental water to the area change in the coming months. The District is leading the effort to import water to the area in accordance with a court ordered settlement of a fifteen year case involving all users of the local groundwater basin.

Board Allows Relief to Customers with High Water Bills Caused by Leaks

In a follow-up from the February 28th, 2013 press release "Board Initiates Process to Allow Relief to Customers with High Water Bills Caused by Leaks," the District's Board, during their regular meeting on March 13th at 9AM, unanimously adopted an Ordinance to allow relief to customers with high water bills due to a leak.

The Ordinance is effective in 30 days and allows staff to grant a customer relief from high water bills in limited circumstances. Relief could only be granted when requested by the customer in writing, the high bill is shown to be caused by a leak, and the leak is repaired. Additionally, relief can be granted to a customer no more than once every three years.

Current District policy still holds that all water metered to a customer is the customer's responsibility. When leaks occur on the customer side of the water meter and go undetected, high water use and high water bills can result.

NCSD may begin processing water applications

Ordinance could get stalled projects moving

Applications for water service from Nipomo Community Services District could be processed soon if the board of directors approves a proposed ordinance this week.

If approved, the ordinance would allow two pending projects — the Jim O. Miller Park and an assisted-living facility on Mary Avenue — to obtain intent-to-serve letters from the district.

Directors introduced the ordinance at the Feb. 27 meeting after receiving a final committee report that found a pipeline from Santa Maria would be the most feasible means of delivering supplemental water to the Mesa.

The final report affirmed the Supplemental Water Alternatives Evaluation Committee's draft version that prompted NCSD directors to call for construction bids at their Feb. 13 meeting.

Buying a blend of state, Twitchell Reservoir and groundwater from Santa Maria would provide adequate water for five to 10 years, district officials said.

However, the committee also recommended that NCSD work with other purveyors and the county to establish longer-term regional solutions.

"The committee's report appears to confirm a project to construct a waterline between the city of Santa Maria and Nipomo is the most feasible water supply available in the near term and also is a key component of long-term regional solutions that require transfer of supply throughout the greater Santa Maria groundwater basin," said Michael LeBrun, district general manager.

He added the report also recommended changes to the district's water conservation program.

After an assessment to pay for a proposed pipeline failed in a public vote last year, NCSD directors passed an ordinance that halted processing of new water service applications.

Since then, the district has come up with a downsized project that can be funded without any new assessments or taxes.

With a clear schedule for building the revised project, directors agreed to suspend the ordinance that halted the processing of applications.

A suspension, rather than a full repeal, will allow directors to re-establish the previous policy if circumstances alter the pipeline timetable, NCSD officials said.

Directors are scheduled to consider the ordinance for final adoption at their meeting set for 9 a.m. Wednesday in the district office data have been will be one effective in

30 days.

In other water issues, directors introduced an ordinance that would allow customers to seek relief from high water bills caused by an undetected water leak.

That ordinance is also scheduled for final adoption at Wednesday's meeting.

Under the district's tiered water rates, the cost per unit of water jumps incrementally as water use escalates into higher tiers.

The tiered rates are designed to encourage water conservation but could lead to astronomical bills if a leak on a customer's property goes undetected for a period of time.

Under the proposed ordinance, relief could only be granted when requested by a customer in writing, if the high bill is shown to be caused by a leak and if the leak has been repaired.

Relief could only be granted to a customer once every three years.

Also last week, directors awarded a \$200,000 contract to Sansone Co. Inc. of San Luis Obispo to reconstruct the district's Blacklake Well No. 4.

Sansone submitted the apparent low bid among five received by the district.

Cannon of San Luis Obispo designed the project and will provide construction management under a separate contract.

The Nipomo Community Services District will once again process new applications for water service.

The district had placed a moratorium on water hookups last June after local property owners voted against paying \$26 million to build a water pipeline from Santa Maria.

District officials maintain that additional water is necessary to reduce over-pumping of Nipomo's only source of water, an underground aquifer.

The board voted unanimously on Wednesday to again start processing new applications for water service, according to a news release from the district. The change went into effect immediately.

However, the board voted to suspend — not repeal — its previous action, which gives it "flexibility to reestablish the previous policy (of no new water connections) should the circumstances for delivering supplemental water to the area change in the coming months," according to the district.

The district has put the first phase of a revised pipeline project out to bid and could award a contract in April. The revised project would be built in phases.

The first phase, estimated to cost \$14.1 million, would connect a pipeline to Santa Maria's water system, install it across the Santa Maria River and connect to the community's water system. Two other phases of the project are planned to increase the pipeline's capacity.

Making a strong case for desalination

Recently, the Santa Maria Times noted the Nipomo Community Service District's approval of trenching and hooking up to the Santa Maria water system. NCSD will expand its system over time and agreed to purchase water, beginning with 1,000 acre-feet, eventually expanding to 6,000 acre-feet.

Another recent Times article on a snow survey showing January/February to be the driest on record, described the snow pack at Echo Summit at 57 percent of an average year. On average, only 15 percent of annual rainfall comes after January/February.

Meteorologists state there will be less precipitation, but stronger storms. For semi-arid areas like the Central Coast and further south, this is not good. The state Department of Water Resources notified Central California farmers to expect water delivery at about 25 percent of normal, and Southern California about 40 percent of normal delivery.

With climate change, one can expect snow packs in the High Sierras will be unstable in the future. The Weather Channel discussed at length climate change as big storms hit the plains, Midwest and East this winter. One problem discussed was the dredging of the Mississippi River so barges could continue to navigate. They also discussed how much rain would have to fall to bring back average levels of the Mississippi.

As for Santa Maria, one should get on board with a plan to build a gasification power plant using sewer sludge for methanol. Santa Maria captures methane gas from the landfill to generate electricity for Marian Hospital.

In using gasification, the power could be used to desalinate ocean water when rains fail to bring the needed water. This would cost us money to build but it could be used when the snow packs are too small.

Remember back during the serious drought that ended in the March Miracle in 1993? Santa Barbara constructed a desalination plant during the drought. Santa Barbara's Gibralter Dam had very low water levels. It was clearly a smart move, but then the rain returned to normal cycles. Unbelievably, the city sold the desalination equipment to the Saudi Arabian government, leaving Santa Barbara in the same vulnerable position.

With rainfall becoming more unstable, it would appear Santa Barbara should have kept the plant idle until the next drought. Independent scientists and meteorologists agree change is happening, and most agree it is not a singular event, but numerous changes occurring around the globe that are happening at a much faster pace than originally thought. They know glaciers in the Andes, Alaska, the Arctic, Antarctic and Greenland are retreating much faster than in prior years.

One can pay attention to the weather changing to warmer drier periods with intensely big storms like tornadoes and hurricanes. The major storms that hit this year were predicted as being very intense once the storms formed, like Hurricane Sandy that hit the Northeast.

So far here on the Central Coast, it seems our future will be drier with fewer rain events, but meteorologists will have difficulty predicting any future changes. Once they can get a clear formation pattern on an individual storm they can determine the impact.

It is in the best interest of the Santa Maria Valley to build a desalination plant to ensure its water suppy, as the future is very unpredictable. With so much independent scientific information pointing to climate change, denial and inaction are not options.






