GENERAL MANAGER'S REPORT

ITEM

Standing report to your Honorable Board -- *Period covered by this report is September 21, 2013 through October 4, 2013.*

DISTRICT BUSINESS

Administrative

- Filling staffing vacancies remains a top priority. Recruitment for Wastewater Supervisor, Utility Operator and Customer Service is ongoing. District Billing Clerk has announced her retirement after 23 years of service to the community. Recruitment to fill the Clerk position will begin the week of October 7.
- Will-Serve Letters were issued to a single family residence in the Summit Station area and the Board approved commercial (medical building) development on West Tefft.
- Two \$75 rebates for high water efficiency clothes washers were granted. Twenty washer rebates have been issued since July 1 as compared to thirty-one rebates issued July 1, 2012 through June 30, 2013. There have been 260 rebates, totaling over \$19,000, issued since program inception in 2008.
- There have been twelve leak related bill reductions processed in accordance with the Bill Relief Policy your Board adopted last winter. A cumulative reduction of \$7,900 has been granted.
- During the month of September the Billing and Board Clerk received 331 walk-in customers. 288 of those customers were paying bills or adjusting an account. 17 came in to discuss high bills, 14 for development related issues. Another 228 customer phone calls were received during the month with a very similar break down in type. Overall 81% of the 559 customer contacts were related to account payment or account inquires. A total of 2 complaints were received, both via the phone.
- Most recent data from Nipomo area County rain gauges recorded no rain during the past two weeks. County rain gauges are reset on July 1 each year. The Nipomo South gauge (Sensor 730) measured total rainfall for the year of 7 inches, 44% of the 16-inch annual average. The Nipomo North gauge (Sensor 730) measured 5.9 inches for the past year, 33% of the 18 inch annual average. Twitchell Reservoir reports 0.0% capacity (at gauge minimum); Lopez Lake stands at 64.2% capacity (31,690 Acre-feet). *This is UP slightly over the past two weeks.* The District does not have access to Lopez water, however Lopez is a major source of recharge to the Northern Cities Management Area portions of the Santa Maria Groundwater basin.

Semifinalists named in scholarship program

Holler Charles, an Arroyo Grande High School student and Lisa Malina, a Pigeon Point High School student, were the only Central Coast students listed in the National Merit Scholarship Corporation's list of approximately 26,000 semifinalists for 2014.

Officials released the list

for the 59th annual National Merit Scholarship Program last week.

Semifinalists, high school seniors, cannot compete for the 8,000 National Merit scholarships that will be offered next spring. But each semifinalist has the opportunity to progress to the final round and win part of the \$5 million total scholarship award for winners.

Semifinalists must fulfill several requirements to advance to the final level. About 90 percent of the semifinalists are expected to attain the finalist standing, and more than half of the finalists will win a scholarship.

Community college offers scholarships

Hancock College is encouraging both continuing students and those who plan to transfer next year to apply for scholarships.

Awards, based upon academic merit and enrollment, totaled more than \$100,000 last year.

To be eligible, applicants must be enrolled at Hancock, maintain a cumulative GPA of 3.0 or better and successfully complete six or more units this fall and another six in the spring semester.

Nipomo CSD Board of Directors Award Contract for Rate Study and Capacity Charge Study

On Wednesday, September 25th, the District's Board held its regular meeting at 9AM and awarded a contract for a water rate and capacity charge study to Clayton Tuckfield and Associates of Newport Beach, California. The contract is valued at \$38,000.

At the July 10th Board meeting, the Board of Directors authorized circulation of a request for water rate and capacity charge study proposals. The District broadly circulated the request to industry professionals and organizations. Five firms responded with proposals.

Clayton Tuckfield and Associates's proposal outlined a comprehensive study of District water rates, charges, and fees and an estimated completion time of 8 months. Tuckfield was the lowest of the five proposers as well.

The study will be conducted over the next several months and include a number of public meetings and workshops. Rate studies are conducted to assess the current and projected financial 'fitness' of the District's various independent funds. In this case, the water fund, which all District water customers support through rates, will be evaluated.

General Manager, Michael LeBrun, commented that the goal of the study is to "develop a fair and equitable water rate structure that will allow the District to meet its financial, contractual, and legal obligations, while ensuring long-term financial stability of the Water Fund."

Construction project on schedule

Boring under Santa Maria River nearly complete

Workers boring horizontally beneath the Santa Maria River could begin pulling 2,700 feet of pipe through the hole as early as next week in the first phase of a project to bring supplemental water to the Nipomo Mesa.

Two crews from ARB Inc. are simultaneously drilling a 42-inch hole 25 feet below the riverbed and fusing together 40-foot sections of high-density polyethylene pipe at the north end of Blosser Road in Santa Maria.

The Nipomo Community Services District project is on schedule despite funding and environmental issues that delayed the start of construction, said Michael LeBrun, district general manager.

If work continues at its current pace, NCSD will hold a ceremony Wednesday, Oct. 23, to celebrate completion of the pipe that will run beneath the river.

"We didn't have a groundbreaking because, literally, we had to get the ground broken," LeBrun said as he stood atop the Santa Maria River levee to survey the progress below. "We didn't have time for that pomp and circumstance."

A permit from the California Department of Fish and Wildlife requires drilling to be complete by the end of October, and "we're on schedule for that," he said.

Drilling from opposite sides of the river, ARB drilling crew workers completed a pilot hole under the riverbed Sept. 6.

As of Monday, they were in the middle of the second of three passes to enlarge to bore to 42 inches to accept the 30-inch pipe.

Meanwhile, fusing crew workers had completed about 2,000 feet of continuous pipeline, which rested on giant rollers along the edge of agricultural fields in the river bottom.

Once the full 2,700-foot pipe is completed, the line will be filled with water and pressure tested, LeBrun said.

If it passes, workers will use a special tip on the drill string to pull the entire length around about a 7-degree curve and through the hole.

"We expect the pull to take one to two days," LeBrun said.

Once it passes a second pressure test inside the bore hole, contractors can start work on the other two Phase 1 packages.

"This is the most technically complex portion of the project, so we wanted to get under the river before we issue the notices to proceed on the other two bid packages," LeBrun said.

One of those packages consists of laying pipe along Blosser Road to connect the south end of the under-river pipeline to Santa Maria's system at Taylor Street.

The other will connect the north end of the under-river line to NCSD's system on Orchard Road, with a pump station and 500,000-gallon storage tank on a plot of land already purchased by the district.

When Phase 1 of the project is complete — targeted for May 2015 at a cost of \$17 million — the pipeline will carry 650 acre-feet of water per year from Santa Maria's system to NCSD's system.

Phase 2, which LeBrun said could be started before the first phase is complete, will boost the capacity to 1,600 acre-feet a year.

Phase 3 will bring the total annual flow to 3,000 acre-feet and the total cost to an estimated \$21 million — in today's dollars and not including any additional design costs for phases 2 and 3.

An acre-foot is about 326,000 gallons, or the amount of water generally considered necessary to serve four to 10 people a year.

To put that in perspective, it's enough water to cover a regulation football field one foot deep.

Although the pipeline project has been criticized by Nipomo area residents for a variety of reasons, LeBrun said recent reports about water shortages have brought "a broader and greater understanding of the need for this water."

"Is six inches of rain our new average?" he asked, noting other Nipomo Mesa water purveyors are already preparing for a severe water shortage next spring.

"If we're dry this winter, we may well see some mandatory restrictions (on water use) next spring," he said.



Pipeline a response to water settlement

The supplemental water pipeline now under construction is Nipomo Community Services District's response to a stipulated judgment in a lawsuit filed more than a decade ago over rights to water in the Santa Maria Valley Groundwater Basin, which extends all the way to Pismo Beach.

Under the stipulation, NCSD was required, with financial support from other Nipomo Mesa water purveyors, to annually import 2,500 acre-feet of water to reduce pumping from the basin.

NCSD decided buying Santa Maria's excess state water allocation and pumping it to the Mesa would be the most cost-effective immediate solution.

"The stipulation envisioned this very project," NCSD General Manager Michael LeBrun said of the pipeline currently being installed under the Santa Maria River.

But launching the project was delayed first by financing problems, then by a lawsuit and finally by a frog.

Plans for a full-scale project were halted when Nipomo property owners rejected an assessment district to finance construction.

NCSD then developed a phased project that would start with a scaled-down system built using a loan plus money from several district funds.

That prompted a lawsuit by the Mesa Community Alliance, which charged the district's use of one of those funds was illegal, and another delay.

District officials got the project back on track by borrowing \$4 million in lieu of using that fund.

Although the lawsuit is still active, no trial date has been set, and NCSD is forging ahead with the first phase of the pipeline.

LeBrun said even if the judge rules against the district, it won't affect Phase 1 and likely won't delay Phase 2, although NCSD would need to find another financing plan.

The last hurdle the district had to clear was erected by state and federal laws protecting the endangered red-legged frog.

To protect the creature, crews had to install a plastic fence around the construction area that extends down into the dirt to prevent any of the frogs from getting inside.

"We must go in every day with a biologist and survey the sites to make sure nothing got inside the exclusion fencing," LeBrun said.

Outreach to Teachers

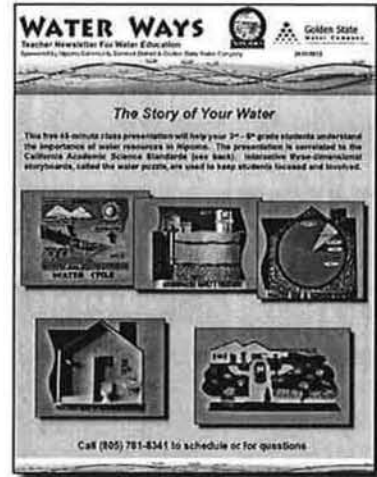
In September of 2012, Science Discovery distributed *Water Ways* to all grade 3-6 teachers at the three public elementary schools in Nipomo (Dana, Nipomo & Dorothea Lange). The *Water Ways* newsletter promotes the water conservation class presentation, *The Story of Your Water*.

Program Demand

Five classes (grades 3-6) received water conservation presentations. With an average of approximately 28 students per class, it is estimated that the total program outreach was 140 students.

No program requests were received from Nipomo or Dana, Elementary. Science Discovery staff delivered a second *Water Ways* Newsletter to teachers, in an effort to increase demand at these schools, however no calls for programs were received.

Four additional water conservation class programs were completed in Nipomo, under contract with the San Luis Obispo County Public Works Dept.

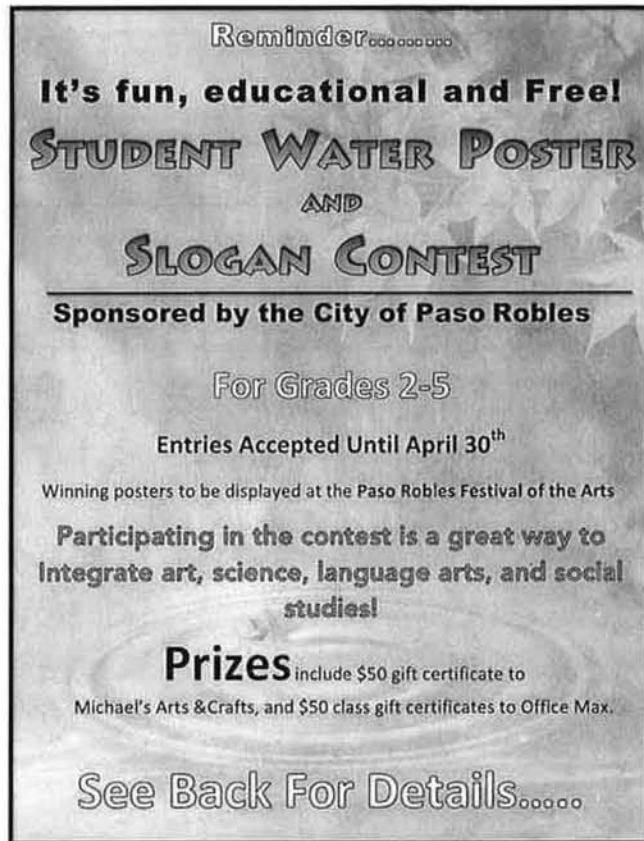

Conclusion

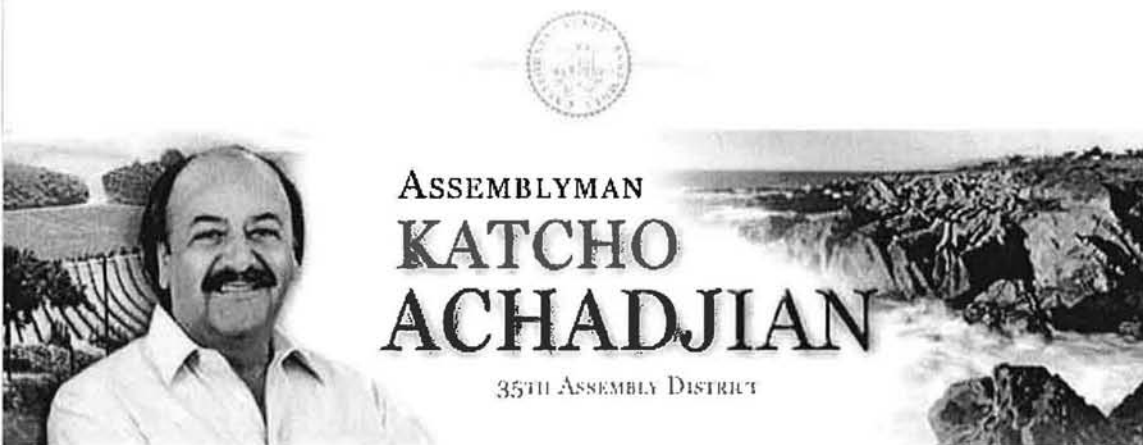

2013 Legislative Update

The early hours of September 13th marked the end of this legislative year. The last few days of session moved at a frenetic pace due to the hundreds of bills coming to the Assembly floor for a vote. As you may know, I did not come to Sacramento to add to the excess number of bills that are introduced each year, but I am happy to announce that I was able to send four common sense pieces of legislation to the Governor's desk. These bills were sponsored by local governments, law enforcement and businesses in our district.

The Governor has already approved three of these bills with his signature:

AB 65: Rape Prosecution –This bill will protect victims of rape by clarifying that a perpetrator who induces a victim into sexual activity by impersonating anyone other than themselves is guilty of felony rape. AB 65 was sponsored by Santa Barbara County District Attorney Joyce Dudley and inspired by an actual case in Santa Barbara County. This bill is a reintroduction of AB 765 that I introduced in 2011, which was held by the Senate Public Safety Committee despite receiving unanimous support in the State Assembly.

AB 461: Liquor Licenses – This bill will provide additional liquor licenses to be sold in San Luis Obispo County. It allows for five additional liquor licenses to be sold over the next three years to eating establishments with 50 or more diners until December 31, 2016. Current law limits the number of liquor licenses based on county population without taking into account factors such as tourism, which may increase the demand for licenses in certain counties. Similar legislation was approved for Marin County in 2012.

AB 685: Peace Officer's Firearm – This bill will allow the spouse or domestic partner of a peace officer who was killed in the line of duty to purchase the fallen officer's state-issued handgun. Under existing law, a duly retired peace officer can be authorized to purchase his or her state-issued handgun. However, there is no system currently in place, when a peace officer has died in the line of duty, for their spouse to purchase their handgun. This oversight in existing law has resulted in spouses of peace officers who have died in the line of duty being denied a chance to purchase a meaningful heirloom for their family.

The fourth measure is still pending action from the Governor. He has until October 13th to sign or veto the bill:

AB 610: State Hospital Reimbursement – This bill would ensure that counties that host a state hospital are not financially burdened with the cost of conducting involuntary medication hearings on behalf of a county that has requested that a mentally disordered offender remain in the state hospital beyond parole. This bill was sponsored by San Luis Obispo County, to ensure they are fully reimbursed for providing services on behalf of other counties.

Tolosa Children's Dental Center Celebrates 10th Anniversary

I am pleased to announce that the Tolosa Children's Dental Center (TCDC) celebrated their 10th anniversary on September 12, 2013. Formally named La Clinica de Tolosa, the TCDC was established in 2003 after the Partnership for Children (PTC) of San Luis Obispo County learned about the large number of children affected by a lack of access to dental services. Knowing the importance of oral health, the PTC's collaboration with the SLO County Board of Supervisors, the First 5 Commission, many local partners, organizations and community members has resulted in providing thousands of local children with professional dental care.

The Tolosa Children's Dental Center has been rallying support for their newest campaign to raise money for children whose families cannot afford dental insurance but whose income level is too high to qualify for public assistance. Currently, the TCDC is collecting donations to support the Oral Health Safety Net Fund to help raise money for these children.

Crystal Oaks Specific Plan. The South County Area Plan Inland identifies the Canada Ranch property as an urban expansion area for a combination of commercial service, commercial retail, and residential uses. The area is intended to provide job generating business to help improve the present jobs/housing imbalance in Nipomo. Protection of natural resources including the large oak woodland areas is also a major priority. Development of the site must be preceded by preparation of a Specific Plan in accordance with the California Government Code. The Area Plan identifies the Canada Ranch Specific Plan area property on both the west and east sides of Highway 101, however only the portion west of Highway 101, approximately 288 acres, is the subject of this Specific Plan. The Specific Plan for the western portion of the Canada Ranch (hereinafter referred to a Crystal Oaks Specific Plan) will be prepared under the guidance of the County. The site of the proposed development is located northwest of Sandy Dale Drive, west of Highway 101 and the Frontage Road, and south of the proposed Willow Road extension and intersection. The applicable General Plan /Ordinance requirements can be see in the attached Exhibit 1, Title 22 Land Use Ordinance, Article 9 South County Rural Area Standards, page 9-287 and 288; and Exhibit 2, South County Area Plan-Inland page 4-10 and 4-11.

Kaminaka. Request for a Land Use Element amendment application (LRP2004-00006) to: 1) amend the South County Area Plan by changing the land use category on an approximately 59 acre site from Agriculture to Recreation and extending the Urban Reserve Line to include the subject property; 2) change the Agriculture and Open Space Element land use designation from Small Lot Rural to Urban Lands; and 3) disestablish the agricultural preserve on the site. The site is located on the south side of Pomeroy Road, between Calle Fresa and Camino Caballo, northwest of the community of Nipomo. The purpose of this request is to allow development of 30 single family residences with the remainder to be used for community recreational fields and trails. Supervisorial District No. 4

Vista Grande. A Vesting Tentative Tract Map and Conditional Use Permit to: 1) subdivide an existing 1.14 acre parcel into eighteen residential parcels ranging in size from approximately 765 to 1,509 square feet each, and one parcel for common active recreation area, parking, and drainage; and 2) construct 18 single family residences ranging in size from 1,348 to 1,635 square feet.
