
INTENT-TO-SERVE CO-90-208 (PRUITT)

The District has received a request from Don Pruitt for a time extension of an Intent-to-Serve letter for Parcel Map CO-90-208. The proposed project is for a recreational vehicle and ministorage area, as shown on the attached map. It is recommended that your Honorable Board approve an extension of the Intent-to-Serve letter for Parcel Map CO-90-208 with the following conditions:

- 1. Enter into the District's Plan Check and Inspection Agreement
- 2. Dedicate a 20-foot utility easement on the northerly side of Camino Caballo centerline.
- 3. Dedicate a 10-foot utility easement to the District on the northerly property line of the project.
- 4. Grant a 20-foot utility easement in Inga Rd. from Camino Caballo to Frontage Rd.
- 5. Install an 8-inch water line in Camino Caballo and loop it through Inga R. to Frontage Rd.
- 6. Water meter sizes are determined by the Uniform Plumbing Code.
- 7. Submit improvement plans to the District for approval.
- 8. Pay all appropriate District fees.
- 9. Install a 3/4 inch conduit between the meter and the phone jack on the house for future automatic meter reading capabilities.
- 10. Enter into an agreement to participate in future sewers for this area.
- 11. Submit the following:
 - 1) Reproducible as-builts
 - 2) Offer of Dedication
 - 3) Engineer's Certification
 - 4) Summary of costs of water improvements

The proposed development is outside the District's Wastewater Prohibition Zone, therefore, connection to the Districts sewer system in not required. At the present time, it is being proposed that one office and one residence be located on the property. An on-site waste disposal system is proposed and may be adequate for this development.

Upon Board's review of this item, they may approve an extension to the Intent-to-Serve letter with the above conditions for Parcel Map CO-90-208.

Request bids to construct an Inter-Tie Between the Town Division and the Black Lake Division water systems.

BACKGROUND


The District operates two separate water systems. One is the Town Division and the other is the Black Lake Division. An analysis of the water production requirements of the Black Lake Division, based on build-out with its major producing wells down, would need a back-up water supply of approx. 200 gpm. This inter-tie between the two divisions is designed to supply the Black Lake Division with the necessary 200 gpm back-up water supply.

The Black Lake Division, through developer contributions, has established \$158,000 for the construction of the inter-tie, at an estimated cost of \$40,000 and a pro-rated cost of the construction (200 gpm) from the new Sun Dale Well. The construction of the Sun Dale Well is completed and ready to be put on line.

Attached is a sketch of the connection between the District system and the Black Lake system and a piping detail of the inter-tie.

RECOMMENDATIONS

It is recommended that your Honorable Board approve the request for bids to construct the Black Lake Inter-tie. A motion would be in order to approve the request for bids to construct the Inter-tie.



CALIFORNIA PUBLIC RETIREMENT SYSTEM

ITEM

This is a proposal to amend our contract with PERS for 2% at 55 full formula.

DISCUSSION

NCSD is a member of the California Public Employee's Retirement System (PERS). The District's current contract with PERS is called 2% at 60 full formula. This refers to the formula used to determine the benefits received upon retirement (the formula utilizes the following-number of years of service, final compensation and age at retirement). By adjusting the contract to 2% at 55, it would allow an employee to retire at an earlier age. Earlier retirement may provided the District with benefits such as reduced cost for tenured employees, possibly less workers compensation claims, assist in the recruitment of employees and greater loyalty. It has been a general trend in our culture towards younger retirement and this includes the public sector. It should be noted that this change would not have any affect on employees over the age of 63.

PERS performed an actuarial valuation analysis for the 2% at 55 and determined that the change in the employer contribution rate would be 1.782% per year. This would bring the employer's contribution to 6.793%. There would not be, however, any out-of-pocket cost to the District for this change for twelve years due to the excess assets the District has on deposit with PERS. The excess assets were created primarily from legislative changes made by the state on how PERS actuarial valuations are conducted. Currently, the District's contribution rate is 0% and that would be expected to continue for twelve years.

RECOMMENDATION

It is recommended that the Board consider modifying the contract with PERS to 2% at 55 full formula. If your Honorable Board wishes to proceed with this item, they may so direct staff to bring back the necessary resolutions to proceed with the modification of the PERS program.

Obispo County General Plan

The public review draft of the proposed Economic Element of the San Luis Obispo County General Plan is now available for your review and comment.

The Economic Element contains goals, policies and programs that establish a context and priorities for economic development in the unincorporated area of San Luis Obispo county. The goals contained in the document recognize the importance of economic activity in enabling the county's residents to find employment and pursue the lifestyles that they value. The policies and programs for each goal describe principles that will guide decision making and actions that will be taken to achieve those goals.

The Economic Element represents a new addition to the county General Plan. It is considered an optional element since it is not required by state general plan law. Its development was spearheaded by the county Economic Advisory Committee with funds allocated by the Board of Supervisors.

A public hearing before the Planning Commission is tentatively scheduled for April 8, 1999. A notice will be published confirming that date. After action by the Planning Commission, there will be a 60+ day review period before document goes before the Board of Supervisors. If you wish to comment on this public hearing draft, you may do so by speaking at the public hearing and/or by providing written comments.

The Nipomo Community Services District Board of Directors has adopted a plumbing retrofit water conservation program. Under this program the Board requires the developer of annexed property to reduce water consumption in the District by replacing old water wasting fixtures in exchange for service. The retrofit would include the replacement of the following fixtures:

Toilets - Replace with ultra low flow 1.6 gallons per flush

Bathroom water faucets – Install aerators designed for 2.5 gallons per minute

Showerheads – Replace with 2.5 gallons per minute with shut-offs

Pressure Regulator – Check and set or install pressure regulator not to exceed 80 psig

The fixture replacements provide for considerable water savings in the average house. This means your water bill could be reduced. The District encourages your participation in this completely voluntary program. There is no cost to you to participate.

If you are interested in having your home retrofitted, please complete the attached form. Your name will be provided to individuals required to retrofit under this program. They will contact you directly to rnake arrangements to have your plumbing retrofitted.
