SUBJECT: REPLACEMENT ENGINE FOR THE EMERGENCY GENERATOR

Dan Gregory of DG Repair has located a 2005 Caterpillar C15 engine. We submitted the specifications for the engine to Tim Fuhs, Air Quality Specialist, Air Pollution Control, for approval. Mr. Fuhs has sent a fax stating that the subject engine meets the State ATCM 0.15 g/bhph standard for backup generators in the State of California.

The engine is located in Chicago and is being held for us pending Board approval. The cost of the engine is \$13,500 plus \$750 shipping. There will be additional labor costs as well as machine work involved in order to install the Cat engine on our existing Rolls Royce generator.

THE RECOMMENDED ACTION BEFORE YOUR BOARD IS TO: BY Board discussion, Public comment, motion, second, and roll call vote:

- Direct staff to transfer \$13,500 plus \$750 shipping costs, for a total of \$14.250, from Restricted Reserves for Capital Improvements/Replacement of Fixed Assets (02-4400-351) to (Replacement Fixed Assets) (02-4400-321), and,
- 2. Authorize staff to proceed with the acquisition of the engine.
