REPORT for May 2009

During the month of May, the department responded to a total of 65 calls. 28 were in Oceano, 12 were in Grover Beach, 10 were in Arroyo Grande, 10 were with Cal Fire and 5 on the beach. Of the 28 calls in Oceano, 19 were EMS related, 2 fire and 7 miscellaneous calls. This put the total as of this report to 353. This time last year the call total was 312. The department averaged 2.1 calls per day.

Training-

Joint Training with Arroyo Grande and Grover Beach FD

Wildland Firefighter Safety, Fire Shelters, Heat related injuries and progressive hose lay evolutions.

The three departments also hosted a Wildland Urban Interface drill that was attended by numerous fire departments within the county. The drill allowed the participants to train in structure protection, mobile fire attack and water shuttle. Big kudos to Chief Heath and the rest of the personnel that assisted with organizing the event.

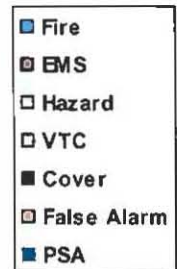
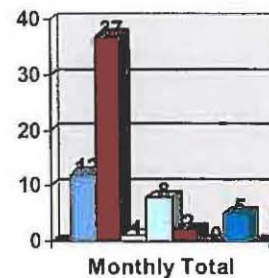
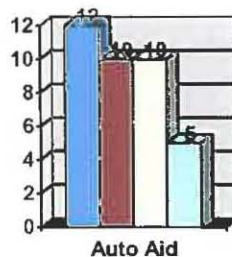
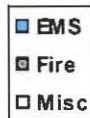
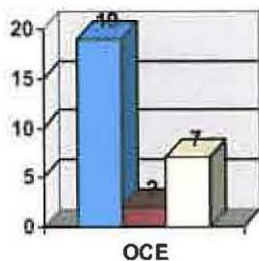
Equipment-

We had to replace a tire on the Patrol 61 because of damage to the bead. Since the tire is being discontinued, we chose to order an additional tire as a backup.

Operations-

The fire department completed the grant process for the 2009 AFG Grant and continuing to work on finalizing the 2008 AFG Grant for the exhaust removal system.

The department is close to purchasing all the items that were funded for the 08-09, we did receive the turnout lockers, digital camera's, Brush 61's storage lockers and the hose roller. We still need to purchase the ventilation fan, hand held radios and a hydraulic hose.

Booth Set-up Self Checklist

- ◇ The stand is not more than 12' in depth.
- ◇ The stand is at least 10' from the property line and at least 100' from any other stand.
- ◇ The stand is at least 30' from any building, at least 10' from any structure other than a building and 10' away from a container storing product.
- ◇ The front of the stand is completely enclosed from the counter to the roof with wire mesh, the openings do not exceed 1/4" in size.
- ◇ Openings to allow delivery of merchandise to customers are not larger than 12"x18" in size.
- ◇ There is a shelf at the counter window(s) extending inward a minimum of 6".
- ◇ The stand has adequate exits that are diametrically opposed and are not more than 20' from one another and swing in the direction of egress.
- ◇ Door latches do not cause undue delay when exiting.
- ◇ All merchandise is stored or displayed at a safe distance from the front and side walls of the stand.
- ◇ All weeds and combustible materials are cleared at least 50' from the stand
- ◇ The stand is equipped with at least one 5lb dry chemical fire extinguisher and one 2 1/2 gallon water extinguisher. Water extinguisher may be substituted by a 5 gallon pail of water at each exit.
- ◇ The aisle way within the stand is clear and unobstructed at a minimum of 24".
- ◇ There are no electrical or fuel operated heaters within the stand and there are no low voltage battery systems or generators in use in or within 10' from the stand. Surge protected power strips must be utilized within the stand.
- ◇ Temporary parking is adequate and must be at least 10' from the stand.
- ◇ **"NO SMOKING" signs are displayed**

Additional Rules

- ⇒ The sale of fireworks is only permitted from June 28th - July 4th. The operating hours will be limited to 9 am to 9 pm each day.
- ⇒ **No person under the age of eighteen(18) years of age is allowed to participate in the operation of the booth or retail sales of fireworks.**
- ⇒ Trash and debris are not to be accumulated in or around the stand.
- ⇒ It is unlawful within the State of California to sell, give or deliver Safe and Sane Fireworks to anyone under sixteen (16) years of age.
- ⇒ No person may be paid for participation in the operation of the fireworks stand, except as a night watchman or security personnel.
- ⇒ No persons remaining at the booth site shall sleep in the booth or occupy a secured booth.
- ⇒ If fireworks are to be stored nightly in an area other than the fireworks booth, the location and **storage container** must be approved by the Fire Chief or designee.
- ⇒ In no case should fireworks be stored in any part of any building or occupancy.
- ⇒ In no case should fireworks be transported out of the District of Oceano for nightly storage.
- ⇒ All unsold fireworks stock, associated litter from the stand must be removed by 9 am July 5th.
- ⇒ **The stand will be dismantled and removed from its location no later than noon on July 7th.**
