Annexation proposal fuels Nipomo wate

NIPOMO - A proposed annexation is further clouding the already complex May 19 election on bringing the State Water Project to this community.

State water opponent Paul Luiz said the Nipomo Community Service District plan to annex the Summit Station area, doubling the size of the district, proves Nipomo has enough water for the future without state water.

NCSD Manager Ryder Ray disagrees.

The district has enough water capacity now to serve about 200 homes in Summit Station, he said, but not enough to serve 16,000 more people expected to live in the district in 30 vears.

The district is trying to be "good guys," helping neighbors in need, Ray said. At a recent public meeting, he said plans for a private water company in Summit Station have evaporated.

Private water developers Vern Rauch and Arthur "Hap" Brenizer disagreed.

NCSD, they said, doesn't need to worry about Summit Station because it is close to finishing plans for a private water company to serve the area.

Two Summit Station residents said their neighborhood desperately needs water and would rather get it from NCSD than from the proposed Summit Water Company.

Nancy Ybarra and Gene Kaye objected to water company plans to charge \$25,000 per house to join and buy the system that they will then have to pay monthly service charges to maintain.

"Nobody I'm familiar with wants their service," said Ybarra, who rode around on horseback getting all her neighbors to sign a

"There is no guaranteed water, and \$25,000 is too much." said Ybarra, who lives in the district but wants to build a new home on 13 acres she owns on Summit Station.

The \$25,000 figure, Brenizer said, is just an estimate. "Hopefully, we can get the price down."

More definite cost figures will be available soon, he said, since his company has submitted plans to the county and the Public Utilities Commission, which regulates private water companies.

NCSD submitted a formal application this week to the Local Agency Formation Commission, which regulates annexations in the county.

Summit Station would be the first annexation to NCSD since 1984. It is one of two annexations the district is applying for. Together they'd double the current district area.

"The water situation here has always been bad, even in wet years," said state water supporter Kaye, "but at least we had water."

Ybarra, who opposes state water, said some people on Summit Station are paying \$65 to \$150 every three weeks to have 2,500 gallons of water hauled in because their wells have dried up.

"We could deliver water there by August Brenizer said. "NCSD doesn't have to work about annexations. The district just needs tell people the facts."

The main thing about annexations that worries district officials is that people will think this is setting a precedent.

Summit Station and the golf course are special cases, district officials said, and don't mean NCSD will support any other annexations or will agree to serve any new homes built there.


