GERALD TRIMBLE, RATE PAYER ACCOUNT #317879-5, TO THE GOLDEN STATES WATER COMPANY COMMENTS ON THE PROPOSED DECISION

Pursuant to Rule 14.3(d) of the Commission's Rules of Practice and Procedure, Gerald Trimble hereby replies to the comments of Golden State Water Company (GSWC) filed on March 24, 2008 relative to the Proposed Decision of the assigned Administrative Law Judge (ALJ) dated March 3, 2008 in this proceeding. The GSWC comments about the *superior court*, about the *one thousand parties* to the court, about the Stipulation's relationship to such parties and the court and about the accomplishments of the Stipulation relative to such parties, may be noteworthy, but deflects attention from and misrepresents the intent of this Public Utilities Commission proceeding.

The scoped issues dictate the intent of what the Stipulation must satisfy, and they relate only to PUC Code §851, GSWC and the rate payers.
