Dear Bruce Buel:

In the August 24th, 2009, Agenda Item 3 for the Committee, draft PDF, Page 2, states:

“Subsequently, the District has corresponded with the other three water purveyors to discuss funding options. **All three water purveyors have agreed to enter into a Joint Powers Agreement with the County of San Luis Obispo to utilize an assessment district as their preferred method of funding.** Based on the costs provided above(1), with an estimated 8% bond rate over 30 years, Table 2 provides a summary of the annual debt service payment for each water purveyor. The annual O&M costs are also included in Table 2 for each water purveyor. Each water purveyor will have the opportunity to pay down their bonding amount with the use of reserves.”


I make the following public records requests:

- 1) The PUC approvals of Golden State Water Company (GSWC), Woodlands Mutual Water Company (WMWC), and Rural Water Company (RWC) “agreements”.
- 2) The PUC approvals of Golden State Water Company (GSWC), “Share” in Table 1.
- 3) The PUC approval allowing Golden State Water Company (GSWC) the corporate entity’s agreement and requirements to pay a percentage of cost for the Water Inter Tie Project to be transferred to Golden State Water Company’s customers or Service area.

- 4) The PUC approval allowing Golden State Water Company (GSWC) the corporate entity's agreement and requirements to pay a percentage of cost for the Water Inter Tie Project to be transferred to only the Nipomo part of Golden State Water Company's Santa Maria Service Area.

Because the hearing is scheduled for September 9th I request that all data be provided 48 hours in advance or that the hearing be delayed until the data can be provided at least 48 hours in advance of the scheduled meeting.

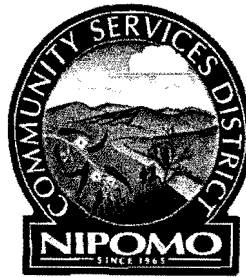


