SUBJECT: APRIL 29, 2011, PUBLIC RECORDS REQUEST TO THE NIPOMO COMMUNITY SERVICES DISTRICT (REQUEST #1)

Please accept this letter in response to your Public Records Request of April 29, 2011, received by the Nipomo Community Services District ("District") on April 29, 2011 which requests the following:

- "In the April 13th, 2011 Agenda, Item D-2 states:
- "H. Director's Request to Staff and Supplemental Reports Director Winn Requested District Counsel to review the pros and cons of utilizing NCSD's Well Site on Riverside Drive..."

I am making a public record request for the "review" that was a result of the Director's request."

In raising the objections to the above request, the District relies on California Government Code Section 6254 which provides that except as provided in Sections 6254.7 and 6254.13, nothing in this chapter shall be construed to require disclosure of records that are any of the following:

- (k) Records, the disclosure of which is exempted or prohibited pursuant to federal or state law, including, but not limited to, provisions of the Evidence Code relating to privilege.

California State law exempts from disclosure:

- Confidential communications from Attorney to Client (the Attorney-Client Privilege) Evidence Code § 954.
- Attorney work product pursuant to Code of Civil Procedure § 2018.030.

Based on Government Code § 6254 and the above referenced State laws incorporated through subparagraph (k) and to the extent that a "review" document exists, the District objects to the request and will not produce documents in response.

This response has been reviewed by District Legal Counsel, Jon S. Seitz, and is the person responsible for raising objections referenced in this response.
