# Desal Plant Means More Water

SAND CITY, Calif. -- On Friday, May 21, officials from the City of Sand City joined local leaders and California American Water to commemorate the start of operations for the city's brackish-water desalination plant. "This project is one of the first examples of a successful new water supply since the Monterey Peninsula was faced with water cutbacks from the state in 1995," said Sand City Mayor, Dave Pendergrass. In 1995, California State

Water Board Order# 95-20 was issued pertaining to the Over-drafting of ground water and lack of new resources on the Peninsula which caused a de-facto building moratorium, impeding much needed redevelopment on the Peninsula and in Sand City as well not allowing The City to eliminate its blighted conditions. After thirty years of effort to secure a new regional water supply and continuous encounters of political and environmental road-blocks, Sand City initiated its own study and evalua-

tion to implement its own water project. Three years of on-going hydro-geological testing provided empirical data for the design and environmental analysis of the project. The City reached out to find the best consultant and engineering teams available to ensure the success of the project. CDM Constructors Inc was the contractor for the design/build of the plant and infrastructure. Local Architect David Martin designed an aesthetically pleasing exterior facade for the treatment facil-

ity to integrate it into the mixed-use (residential/commercial) community. Construction commenced with the extraction wells, pipelines, and the treatment facility. The project also required tunneling and pipeline installation beneath State Highway 1. The City was awarded a \$2.9 Million Proposition 50 Grant monies from the Department of Water Resources to help defray some of the construction costs. The project completion is part of the Planned Regional Water Supply Project.

The brackish-water desal plant will produce 300 acre-feet of water a year for Sand City's eventual build out. But until planned projects are constructed, the desalinated water will help to reduce withdrawals from the Carmel River, which the State Water Resources Control Board has deemed illegal. The Carmel River is the primary water supply for the Monterey Peninsula. California American Water, the area's water provider, is under an obligation to find more than 8,500 acre-feet of alternative

water supplies in order to decrease the community's reliance on the river. The tease-operation agreement with the California-American Water Company allows, initially, a 300 acre-feet per year reduction of pumping water from the over-drafted Carmel River Basin. Robert MacLean, President of California American Water, whose company will operate Sand City's new plant, said the additional water supply is critical to meeting state-ordered reductions on the river. "Just last month, a judge ordered enforcement of the state's cutback order.

Every bit of alternative water that can be identified is a major step toward reducing the threat of water rationing and other penalties to the Monterey Peninsula community. We all owe a debt of gratitude to Sand City for their thoughtful planning and perseverance." The project also incorporates state-of-the-art energy recovery devices to lower the overall energy consumption and operational costs. Truly a proof of a successful public-private project for the Company, the City, and the environment.
