Ed, you are not being honest about NCSD's devotion to its pet contractors and engineers, and about the stacking of the deck in the Supplemental Water Alternatives Evaluation Committee. You say in your post (#3 and #4):

"3. Boyle Engineering is a company that has not existed for a few years. They were bought by AECOM, and their pipeline design engineer no longer works there.

4. If the advisory committee is stacked, it was stacked by a selection committee chosen by Supervisor Teixeira and other mesa water companies, including your own, Rural Water Company. I don't think the selected experts would appreciate your attack of their character as rubber stampers, but you do it with cowardice behind your and Harry's pseudonyms."

While there may be a handful of contracting companies that have handled the Supplemental Water Project (SWP) and the Santa Maria water line project, there is one thing they all have in common: Engineer Mike Nunley, who is the engineer I believe you reference when you wrote "...their pipeline design engineer no longer works there." He may not still work THERE, but he still

works for NCSD, doesn't he? And that's the point: NCSD has followed Michael K. Nunley from contracting company to contracting company.

A simple review of NCSD's records and other public records shows that at least as early as February 2003, Nunley worked for Boyle. Boyle was a

regular provider of engineering services to NCSD from that point through when AECOM absorbed Boyle. Often he was the lead contracted engineer forvery important (and \$\$\$expensive) projects.

At least as early as September 2006, Nunley was the Boyle engineer providing services to NCSD. From that point until AECOM absorbed Boyle (and Nunley), Nunley was a regular provider (through Boyle) of engineering services to NCSD.

On Feb. 11, 2009, AECOM published a press release, "AECOM Buys Boyle Engineering, NUNLEY Joins AECOM." http://pr.aecom.com/phoenix.zhtml?c=211994&p=irolnewsArticle&ID=1106754&highlight=

Whither Mike Nunley goest, so NCSD goest. Nunley didn't even miss a

beat in his engineering for NCSD when he went from Boyle to AECOM; he continued to be NCSD's go-to engineer for (at that point) the waterline project. Nunely continued to provide engineering services to NCSD and, as of at least March 2011, Nunley was still presenting engineering information to NCSD under the AECOM banner. <u>http://ncsd.ca.gov/Library/Board_Packet/2011/BP%2003-09-11/C1&C2.pdf</u>

Then, at least by 8/8/2012, Nunley appears to be working for himself as "MICHAEL K. NUNLEY & ASSOCIATES" (AKA "MKN & ASSOCIATES" in NCSD's board records). Public records indicate his business address was the same as his home in AG. The NCSD Board Packet for 8/8/2012, indicates Mike Nunley (under the "MKN & ASSOCIATES" name) was contracting directly with NCSD. http://ncsd.ca.gov/Library/Board_Packet/2012/BP% 2008-08-12/E1-E3.pdf

The services he was/is providing: he was contracted to be the "SUPPLEMENTAL WATER ALTERNATIVES EVALUATION CHAIRPERSON."

Minutes for the 8/8/2012 board meeting indicate he was UNANIMOUSLY approved by the NCSD Board of Directors: Director Eby, Director Gaddis, Director Winn, Director Vierheilig, and President Harrison.

So, let's review. Boyle engineering contracted with NCSD starting at least by 2003. By 2006, Mike Nunley was, while working for Boyle, providing engineering services to NCSD. From that point until the present time, Mike Nunley has been (irrelevant of what company he was working for, or if he was just working for himself) providing engineering services to NCSD for the Supplemental Water Project (which evaluated different approaches to bringing supplemental water to Nipomo) AND, once NCSD decided on the Santa Maria water line project, the waterline project. (Nunley may have done other engineering tasks for NCSD, but the SWP and waterline project are the two big money-makers.)

Now you are so brazen as to come to a public message board and claim that it is NOT stacking the deck for NCSD to select Mike Nunley's company (the engineer who was FOR YEARS paid by NCSD for his engineering services to help NCSD CHOOSE the Santa Maria water line project, and then to BUILD the Santa Maria waterline project) to head the supposed independent the "SUPPLEMENTAL WATER ALTERNATIVES EVALUATION

CHAIRPERSON"?

One of the biggest complaints I heard from Nipomo residents about the whole Supplemental Water Project and the waterline project, and certainly the assessment district measure they voted down, is that they did not want the Santa Maria water line project to be built. PERIOD.

Despite that, NCSD steadfastly forced the waterline project onto the Nipomo residents. The Nipomo residents finally, after NCSD had wasted so much money on out-of-town public relations hacks and The Wallace Group's services to form an assessment district, got the opportunity to vote

down the measure.

Did that stop NCSD trying to force the waterline project on Nipomo residents? No, it did not. NCSD's general manager, despite a resounding and humiliating voters' statement on his own ability to lead NCSD, continued to

go right on talking to the media as if the only alternative for supplemental water was the water line project.

NCSD tried to make nice with the voters by forming the Supplemental Water Alternatives Evaluation Committee, which was supposed to bring "the people" in on the discussion of the best options for providing additional water to Nipomo in the future. And look at the special-interest gang that got appointed.

First, of course, there is Mike Nunley, the engineer NCSD like a little puppy from new company to new company; the engineer who helped NCSD choose the waterline project, and who then provided engineering services to design the waterline project.

You've already named the members of the committee, so I don't have to say anything about them. These are not "the people." They are people who have vested interests in bringing lots and lots of water to Nipomo, or in currying favor with NCSD and its board of directors.

So your blushing-virgin "what-ME?" comments about cronyism and stacking the deck of the Supplemental Water Alternatives Evaluation Committee prove to be nothing but smoke and mirrors. Unfortunately, "smoke and mirrors" is nothing new for you. Finally, I'm curious. What finally convinced NCSD to protect the best interests of its customers (who have to pay for all of these \$\$\$millions

in engineering services) and stop contracting with The Wallace Group? It wasn't back when reports started coming in about his massive over-billing of

the South County wastewater treatment plant. It wasn't even after, thanks to Wallace's poor administration of the plant, there was a massive raw sewage spill into the ocean, creeks, and spewing up residents toilets, into their homes, was it? The water board fined them over \$1million for that, which its rate payers are going to have to pay for. So when was it, Ed, when the NCSD board finally decided to serve its customers, and not its cronies like Wallace, first?

"Two candidates, Blair and Thompson, said they voted against the plan. During a candidate forum in Nipomo on Wednesday, Blair argued the district board is moving ahead with a pipeline project even though most residents said they didn't want it." 'These people are running this place, going ahead full-steam like you didn't say anything," said Blair. "I don't think that's a way to run a business.'"

Mr. Blair is spot on in his assessment. Nipomo CSD's board of directors is set on the pipeline as the answer to the Nipomo Mesa's water issues. One of the first public comments made by Nipomo CSD's general manager, Michael LeBrun, was to indicate they were going back to the drawing board to find a different way to get the pipeline. The advisory committee is a joke. It is stacked with pro-pipeline members. They are just going through the motions. The outcome is already clear.
