This letter is a request for public records which are in the possession of the Nipomo Community Services District pursuant to the California Public Records Act (Govt. Code 6250, et seq.).

NCSD hired a firm to send out a survey, of which the attached is an example. It was requested to be returned by 2/24/12. At a NCSD board meeting it was reported that the survey results would be back around 3/9/12. I am look for the results or tabulation of the responses that show the proportion or ratio of the responses.

The following is a list of the reasonably identifiable public records which I request copies of:

- 1. I am requesting for a copy of any "tabulated results" of the survey.
- 2. I am requesting for a copy of any "reports" of the survey.
- 3. I am requesting for a copy of any "summaries" of the survey.

4. Any other reports/summaries/results reported to the NCSD by True North Research for the period of 3/1/12 to 4/23/12.

If a portion of the information contained in the records we have requested is exempt from disclosure by express provisions of law, Govt. Code 6254 requires segregation and deletion of that material in order that the remainder of the information may be released.

Please take note that Govt. Code 6256 requires the Nipomo Community Services District to determine, within ten (10) days after receipt of this request, whether the Nipomo Community Services District will comply with this request. If the Nipomo Community Services District decides not to comply with all or any portion of this request, Govt. Code 6256 requires notification to us of the reasons for the determination not later than ten (10) days from your receipt of this request. Further, Govt. Code 6256.2 prohibits the use of any provision of the Public Records Act to delay access for the purposes of inspecting public records. Govt. Code 6256.2 also requires that any notification of denial of this request for records must set forth the names and titles or positions of each person responsible for the denial.

Nipomo Mesa Supplemental Water Project

Survey of Property Owners

WHY DID YOU RECEIVE THIS SURVEY?


As a property owner on the Nipomo Mesa, you will have the opportunity in the coming months to officially indicate support for or against the proposed formation of Assessment District No. 2012-1 to fund the Nipomo Mesa Supplemental Water Project. Please read the following information and then complete the enclosed questionnaire. Your participation will help your local water provider make important decisions about the reliability of your future water supplies.

BACKGROUND INFORMATION ON WATER SHORTAGE

There is a serious water shortage on the Nipomo Mesa. The Nipomo Mesa communities have just one source of fresh water – a single underground aquifer – to supply all of our fresh water. Over the years, engineers and water experts studying the local water supply have agreed that due to over-pumping our single underground aquifer simply doesn't have enough water to meet our existing needs. Water levels beneath the Nipomo Mesa have fallen significantly over the past 10 years and will continue to fall even if no further development occurs.

SEAWATER INTRUSION AND WATER CONTAMINATION

The threat of seawater intrusion is real. We share our single source of fresh water with the Pacific Ocean. When the fresh water table stays above sea level, seawater stays offshore. Too much pumping of the fresh water supply can cause the fresh water table to fall below sea level, creating an invitation for seawater intrusion. Sea water intrusion has already contaminated water sources in coastal communities just north of Nipomo. If seawater intrusion happens here, experts agree that reversing it is nearly impossible.



WE NEED A SUPPLEMENTAL SOURCE OF WATER

Importing a new source of fresh water is needed to reduce overpumping, avoid the contamination of our fresh water supplies caused by seawater intrusion, and ensure the continuing supply and quality of fresh water to the Nipomo Mesa. Nipomo Community Services District, in conjunction with Golden State Water Company, Rural Water Company, and Woodlands Mutual Water Company, has developed a solution: the Nipomo Mesa Supplemental Water Project.

The Nipomo Mesa Supplemental Water Project will construct a pipeline to connect Nipomo Mesa fresh water systems with the City of Santa Maria fresh water system, which is fed by the State Water pipeline and groundwater. This pipeline will provide a second, reliable source of fresh water for the Nipomo Mesa.

ASSESSMENT TO FUND THE SUPPLMENTAL WATER PROJECT

To fund the design and construction of the Nipomo Mesa Supplemental Water Project, property owners will be asked in the coming months to officially indicate support for or against the formation of an Assessment District. The proposed assessments will be used to directly fund the pipeline's construction or to secure assessment bonds over a thirty (30) year period, the proceeds of which will be used to fund the pipeline's construction. The entire project is projected to take 18 months to complete and cost less than \$26 million. A State grant has already been secured lowering the cost to local property owners by over \$2 million.

If the Assessment District is approved, individual parcels would be assessed a share of the cost to fund the Nipomo Mesa Supplemental Water Project based on the specific benefits of the project to each parcel. The benefits to a parcel are based on service location, zoning, size, use of the property, whether it is currently developed, and its development potential. Property owners will be allowed to choose one of two payment options based on their individual preferences. Property owners may: 1) pay their assessment lien in advance all at one time for a discount; or 2) pay their assessment in smaller annual installments over time on the property tax bill for the parcel, which is payable by the then current owner of the property. Advance payment will allow property owners to avoid interest charges.

The funds raised by the Assessment District can only be used to fund the Nipomo Mesa Supplemental Water Project to benefit your property. The funds can't be taken away by the State or used for any other purpose.
