Adding city's promo dollars

The Buellton City Council race brought up some important issues, the most critical one being whether Buellton should spend such a large allocation for visitors services, or whether there are more pressing needs.

Buellton is spending way more on marketing than first meets the eye.

Buellton hotels have their own tax they collect and use for marketing; it is called a business improvement district. That tax collected in Buellton was \$211,380 last fiscal year. This was combined with what Solvang, Santa Ynez, Los Olivos and Los Alamos hotels collected. The grand total in 2013-14 was \$650.000.

This money is used to market Buellton and the rest of the Valley. All benefit from this collaborative effort.

The Chamber of Commerce received \$326,000 from the city of Buellton in 2013-14. Along with the Hotel Association's tax, total for marketing Buellton was close to \$1 million with just these two organizations. Other organizations — such as Visit SYV, Vintners Association, Solvang Conference and Visitors Bureau and the casino — advertise the Valley and Buellton as well.

To break even on the funds the city gives the Chamber, would require the bed tax to go up 70 percent, or to \$2,718,904.

The community deserves a complete and thorough analysis to determine how much taxpayer money is needed for visitor's services.
